ITEM NO.2 : TO CONSIDER THE PROVISION OF INFRASTRUCTURAL FACILITIES TO THE NEW FARM:

The Governing Body considered the proposal and approved the following items of work.

- Construction of two thrashing floors
 40' X 30' size one each at Western and
 Eastern Block of Sorakudy farm for
 Rs.1.50 lakhs.
 - b. Construction of one farm shed 20' X 20' size in Western block for Rs.0.75 lakhs.

The Dean, PAJANCOA is permitted to undertake the above items of work depending on the availability of funds.

ITEM NO.3: TO CONSIDER THE REPAIRS AND MAINTENANCE OF COLLEGE VEHICLES:

a. Repair of Jeep PYK 7700

The Governing Body considered and ratified the action of the Dean in settling the expenditure to the tune of Rs.67,793.25/towards the Repair work carried out to the Jeep PYK 7700.

b. Purchase of Tyres for the college bus Py-02 1197.

The Governing Body considered and approved the proposal for the purchase of numbers of new tyres to the College Bus (PY-02 1197) at a cost of Rs.39,000/-

ITEM No.4 : TO CONSIDER THE PROPOSAL OF SETTLEMENT OF TENDERS:

- a. The Governing Body considered and approved the lowest tender of Thiru.

 K.R.Subramanian, Neyveli at his tendered amount of Rs.21,43,700/- which is 35.10% below the estimated cost put to tender of Rs.33,02,850/-
- b. Supply of 350 M.T. Non-Levy ordinary portland cement to PAJANCOA.

 The Governing Body considered and ratified the approval of the Building Committee for the purchase of 150 M.T. of cement through PASIC, Pondicherry, and also approved the purchase of balance quantity of 200 M.T of cement through PASIC, at the rate of Rs.2,027.37/M.T. The Dean, PAJANCOA was permitted to issue work order and supply order for the above works and to incur the expenditure.

ITEM NO.5: TO CONSIDER THE PROPOSAL OF ANNUAL ACTION
PLAN FOR THE YEAR 93-94 (BUILDING PROGRAMME)

The Governing Body considered the proposal and suggested that the building works may be prioritised and a comprehensive proposal may be prepared in consultation with the Development Commissioner. The proposal should also indicate how the works are to be executed in phases over the years depending upon the availability of funds.
