## 3. AGENDA ITEM NO.3 TO CONSIDER AND APPROVE THE ADMISSION NORMS TO B.SC.,(AGRI.) DEGREE PROGRAMME FOR THE YEAR 2002-2003

After a detailed discussion, the Governing Body approved the modified percentage of reservation of seats for B.Sc.,(Agri.) which has already been approved by the Government for PAJANCOA&RI as detailed below:

- i) 50% (30 seats) to the students of U.T.of Pondicherry through CENTAC
- 25% (15 seats) to the students allotted by the Tamil Nadu Agricultural University based on their Entrance Test.
- ii) 25% (15 seats) to the students of other states through ICAR

The Governing Body also directed the Dean to pursue with the Government of Tamil Nadu and Tamil Nadu Agricultural University for the reduction of marks on par with other professional courses of Union Territory of Pondicherry. The candidates from Tamil Nadu Agricultural University and ICAR will continue to have the same requirement of marks as that of Tamil Nadu Agricultural University, until it is revised by Tamil Nadu Agricultural University.

The Governing Body directed the Dean to pursue further with ICAR and Tamil Nadu Agricultural University for the allotment of candidates during the ensuing counselling for all India candidates.
