3. Agenda Item No. 3 of XXXXI meeting:

TO RATIFY THE INCREASE IN ADMISSION STRENGTH (SANCTIONED STRENGTH) OF B.Sc. (AGRICULTURE) FROM 60 TO 80.

The existing sanctioned strength of admission into B.Sc.(Agriculture) degree programme is only 60. Out of this, 85% seats (51 seats) is reserved for the candidates of U.T.of Puducherry and balance of 15% seats (9 seats) is allotted for other states candidates, as per the existing admission policy of PAJANCOA&RI.

The 40th Governing Body meeting held on 16.02.2012 approved the proposal to increase the admission strength of B.Sc., (Agri.) from 60 to 70. The same was placed in 115th meeting of Academic Council of Tamil Nadu Agricultural University, Coimbatore for its approval. The Academic Council suggested and approved 80 seats as sanctioned strength for PAJANCOA&RI, on par with the other affiliated colleges of TNAU. Accordingly, 80 candidates were admitted into the B.Sc.(Agriculture) degree programme at PAJANCOA&RI for the academic year 2012-13, following the existing admission policy of 85% seats (68 seats) to candidates of U.T.of Puducherry and 15% seats (12 seats) to candidates of other states duly adopting existing reservation policy, with the approval of the Chief Secretary and Chairperson.

The Governing Body is requested to ratify the increase in the admission strength of B.Sc.(Agriculture) from 60 to 80, with effect from the academic year 2012-2013.

4.Agenda Item No. 4 of XXXXI meeting:

TO RATIFY THE UPWARD REVISION OF FEES BASED ON TNAU NORMS AT PAJANCOA&RI.

The Tamil Nadu Agricultural University has been increasing the fee structure by 10 per cent for UG and PG students every year. More over the Govt.of Puducherry also issued an I.D.Note No.B.13018/F2/2000(7) dated 05.07.2000 insisting that institutions of higher education run by the societies should generate an additional revenue of 10 per cent of their yearly expenditure. Following the direction of Govt.of Puducherry as well as to fall in line with the norms of Tamil Nadu Agricultural University, the PAJANCOA&RI which is affiliated to the TNAU has been increasing the fee structure every year by 10 per cent since 2000, as approved in the XXVI meeting of Governing Body of PAJANCOA&RI held on 01.08.2000.

The Governing Body is requested to consider and ratify the upward revision of fees by 10 per cent since 2000 as it is a routine matter and also requested to approve the 10 percent upward revision every year in future routinely in line with the norms of TNAU and / or Govt.of Puducherry. Any deviation from 10% upward revision will be brought to the notice of the Governing Body for its approval.

5.Agenda Item No. 5 of XXXXI meeting:.

TO RATIFY COLLECTION OF HOSTEL UTILITY CHARGES.

To generate some income to be self-sufficient, it is proposed to collect hostel utility charges from the students of PAJANCOA&RI. The following are the utility charges collected by various educational societies in the Govt.of Puducherry, as one time measure at the time of admission, which is nonrefundable.

So far utility charges were not collected at PAJANCOA&RI. Considering the necessity of maintenance and upkeep of the hostels and nonavailability of sufficient grants-in-aid from the Government, it has been proposed to collect Rs.5,000/- as hostel utility charges per student at the time of admission as one time measure, which is not refundable. The same was submitted in file to the Chief Secretary –cum – Chairperson for approval. The Chief Secretary –cum – Chairperson, PAJANCOA (Karaikal) Society has approved the proposal for implementation from the ensuing academic year 2013-14. The same was implemented for the recently admitted first year students of the current academic year 2013-14 starting from July 2013.

The Governing Body is requested to ratify the collection of hostel utility charges.

6.Agenda Item No. 6 of XXXXI meeting:

TO CONSIDER AND APPROVE THE PROPOSAL OF ADMITTING STUDENTS INTO B.SC.(AGRICULTURE) PROGRAMME AT PAJANCOA&RI UNDER THE SCHEME OF PAYMENT SEAT / MANAGEMENT QUOTA

As the budget provision for PAJANCOA&RI in the recent years is sufficient only to meet out the salary component of the staff members, there is an urgent need to generate income so as to provide some infrastructural facilities to the students' community in future.

Considering the heavy demand for the B.Sc.,(Agri.) course at PAJANCOA&RI, it is proposed to admit 20 students under payment seat scheme from the sanctioned strength of 80, and if any vacant seat arises from NRI quota of 10% of sanctioned strength (i.e., 8 seats over and above the 80 seats). Therefore, the overall admission strength would be 80+8 NRI seat = 88 seats. Out of this 88 seats, the proposed number of seats to be admitted under payment scheme is 28 (20 from 80 sanctioned strength + 8 from NRI

quota as such or the vacant seats available from NRI quota), as detailed below:

The above proposal was approved in principle by the Government of Puducherry as approved in file by the Secretary (Agriculture), Chief Secretary – cum – Chairperson of PAJANCOA&RI, Honble Agricultural Minister and Hon'ble Chief Minister of Puducherry.

7.Agenda Item No. 7 of XXXXI meeting:

TO RATIFY THE REVISED GUIDELINES TO ADMIT FOREIGN / NON RESIDENT INDIANS (NRI) IN PAJANCOA&RI.

The Academic Council of the Tamil Nadu Agricultural University (TNAU) at its 109th meeting held on 02.07.2009 <u>vide</u> Agenda No.III-8(AC109) has approved to admit NRI / Foreign students at PAJANCOA&RI at the rate of 10 per cent of the sanctioned admission strength. The same was approved by the 38th meeting of the Governing Body of PAJANCOA&RI held on 23.02.2010.

The Tamil Nadu Agrl. University has recently revised the guidelines for the admission of candidates under foreign / NRI quota with reference to maximum age limit and minimum marks of the candidates in its 118th th meeting of the Academic Council held on 20th July 2012. Hence, PAJANCOA&RI has to follow the same as it is affiliated to the TNAU. Therefore a proposal was submitted in file to the Chief Secretary – cum – Chairperson, PAJANCOA (Karaikal) Society requesting approval to follow the revised guidelines of TNAU from the ensuing academic year 2013-14 at PAJANCOA&RI. The same was approved by the Chief Secretary – cum – Chairperson.

The existing guidelines/norms (eligibility criteria) for admission of foreign / NRI candidates for B.Sc.,(Agri.) at TNAU and PAJANCOA&RI is given below:

As such there is no change/deviation from the existing guidelines of Tamil Nadu Agricultural University (SI.No.1,2 & 4) except the fee structure (SI.No.3). That is the fees payable at PAJANCOA&RI is not revised in line with Tamil Nadu Agricultural University. It is restored as such viz., US\$ 1,800/- per semester or US\$ 14,000 for the entire course besides admission fee of US\$ 250 per candidate at PAJANCOA&RI.

The TNAU has proposed / revised the guidelines for admission of foreign / NRI candidates only with reference to maximum age limit (SI.No.1) and minimum marks (sI.No.2) of the candidates as follows. Hence, the same will be followed by PAJANCOA&RI, to fall in line with TNAU .

The Governing Body is requested to ratify revised guidelines in respect of maximum age limit and minimum marks of candidates to be adopted by PAJANCOA&RI from the ensuing academic year 2013-14, as proposed ./ revised by the TNAU.

8.Agenda Item No. 8 of XXXXI meeting:

TO APPRAISE THE GOVERNING BODY OF THE UNDER-GRADUATE AND POST-GRADUATE ADMISSION AT PAJANCOA&RI IN THE ACADEMIC YEAR 2013-14.

The notification for undergraduate programme viz., B.Sc.(Agriculture) was given on 11th May 2013 and applications were issued (sold) from 14th May 2013. The last date for submitting applications was 14th June 2013. After scrutiny of applications, merit lists were prepared and hosted in the PAJANCOA&RI website (<u>pajancoa@ac.in</u>). The counselling for admission as per merit list was held in three phases as detailed below:

- (i) Counselling for 85% of 80 seats (68 seats) for Puducherry candidates was held on two dates viz., 5th and 8th July 2013.
- (ii) Counselling for 15% of 80 seats (12 seats) for other state candidates was held on 10th July 2013.
- (iii) Counselling for 10% of sanctioned strength of 80 seats (8 seats) for NRI quota was held on 12th July 2013 and 19th July 2013

This is the first time that all the eight seats under NRI quota / category were filled up.

Regular classes for the newly admitted first year students commenced on 25th July 2013, in tune with the academic calendar of theTamil Nadu Agricultural University, Coimbatore.

As far as Post-graduate admission was concerned, notification was given in the PAJANCOA&RI website during the first week of June 2013. Applications were issued from 10th June 2013 and the last date for submission of application was 10th July 2013. The Entrance Test was conducted on 22nd July 2013. Merit list was published on the same date. Admission started from 23rd July and completed in the first week of August 2013. Post-graudate programme during the current academic year 2013-14 is being offered in five disciplines viz., Agronomy, Plant Breeding and Genetics, Soil Science and Agricultural Chemistry, Agricultural Economics and Horticulture. At the rate of five students per discipline, 25 students were admitted. This year for want of sufficient teaching staff, post-graduate students were not admitted in the discipline of Agricultural Entomology and Nematology. The regular classes will commence from 17th August 2013 in tune with the academic calendar of the Tamil Nadu Agricultural University, Coimbatore.

The above agenda is submitted to the Governing Body for favour of kind information.

9.Agenda Item No.9 of XXXXI meeting:

TO RATIFY THE MODIFICATION OF THE FOUR LECTURE HALLS OF B.Sc.(AGRICULTURE) UNDER GRADUATE ON PAR WITH THE E-LEARNING LECTURE HALLS OF TNAU, COIMBATORE.

Among the four lecture halls (1st, 2nd, 3rd and 4th year lecture halls) for the B.Sc.,(Agri.), the first year lecture hall in Academic Block B was modified with good quality teak wood furniture at a cost of Rs. 6.86 lakhs with the approval of the Chief Secretary and Chairperson in the year 2012. The work was

entrusted with National Small Industries Corporation (NSIC), Thattanchavady, Puducherry.

Subsequently, the remaining three lecture halls were modified, with good quality teak wood furniture with the approval of the Chief Secretary – cum – Chairperson, during the year 2013. The cost involved is Rs.19,18,884/- as per the quotation given by the NSIC, Puducherry. Work order has been given to NSIC, Puducherry to execute the work. The work is in progress and it will be completed before August 2013.

Hence, the Governing Body is requested to ratify the action taken for the modification of all the four lecture halls of the under-graduate in the Academic Block B.

10. Agenda Item No. 10 of XXXXI meeting:

TO RATIFY THE TEMPORARY SUSPENSION OF POST-GRADUATE PROGRAMME IN AGRICULTURAL ENTOMOLOGY AT PAJANCOA&RI.

The Post-graduate programme in Agricultural Entomology viz., M.Sc.(Agricultural Entomology) was first started in PAJANCOA&RI during the Academic year 2000-2001. While starting the M.Sc.(Agricultural Entomology) in the year 2000-2001, the sanctioned strength of teaching staff in the Dept.of Agricultural Entomology and Nematology was seven (one Professor, two Associate Professors and three Assistant Professors in Agricultural Entomology and one Assistant Professor in Agricultural Nematology). As suitable candidates were not available on direct recruitment for the post of two Associate Professors, subsequently, the said two Associate Professor Posts were converted into two Assistant Professor. Thereby the sanctioned strength of teaching staff did not change but only the number of Assistant Professors post got increased (i.e., one Professor and 5 Assistant Professor in Agricultural Entomology and one Assistant Professor in Agricultural Nematology).

The post of Professor of Agricultural Entomology fell vacant after the retirement of Dr.L.Nadarajan, Professor and Head (Agricultural Entomology) on 30.05.2011. Subsequently, Dr.D.Adiroubane became Professor and Head (Agricultural Entomology) and he also retired on 31.08.2012. Dr.J.Alice Retna Packia Sujeetha, Associate Professor (Agricultural Entomology) had resigned on 30.03.2012. Thereby, three teaching posts became vacant. Despite this vacancy, both the under-graduate and post-graduate programme in Agricultural Entomology were run with the existing four teaching staff (3 in Agricultural Entomology + 1 in Agricultural Nematology) till recently (up to the academic yea 2012-13) with great strain. Anticipating the retirement of Dr.D.Adiroubane, the Dean approached the Tamil Nadu Agricultural University(TNAU), Coimbatore to get one or two teachers in Agricultural Entomology on deputation to PAJANCOA&RI. Anticipating the teachers on deputation from Tamil Nadu Agricultural University, the Post-graduate students were admitted for the Academic year 2012-13. As nobody was willing to come to PAJANCOA&RI from Tamil Nadu Agricultural University on deputation, we were not able to get persons on deputation. Hence, the Under-graduate and Post-graduate programmes in Agricultural Entomology were run with great strain with the available four teaching staff alone. It was unfortunate that an Assistant Professor by name Dr.A.Coumar who was recruited in 2012 died (committed suicide) on 26.05.2013. Hence the teaching staff strength became only three (two in Agricultural Entomology + one in Agricultural Nematology). As it was not possible to go for fresh recruitment due to paucity of time, it was felt that conducting both Postgraduate and Under-graduate programme in Agricultural Entomology will be very difficult with only three staff members. Hence, the Dean, PAJANCOA&RI submitted a proposal to the Chief Secretary – cum – Chairman, PAJANCOA (Karaikal) Society through the Secretary to the Government.(Agriculture) for temporary suspension of Post-graduate programme in Agricultural Entomology during the academic year 2013-2014 which was to commence in August 2013. The proposal was approved by the Chief Secretary – cum – Chairman. The same was also intimated to the Tamil Nadu Agricultural University. However, the Post-graduate programme in Agricultural

Entomology will be revived after getting qualified teaching staff on deputation / direct recruitment in due course of time.

Therefore, the Governing Body is requested to ratify the temporary suspension of Post-graduate Programme in Agricultural Entomology and to revive the same in future after recruiting qualified teachers.

11.Agenda Item No. 11 of XXXXI meeting:

TO RATIFY THE RECRUITMENT OF ASSISTANT PROFESSORS AT PAJANCOA&RI IN 2012.

The 39th meeting of the Governing Body of PAJANCOA&RI held on 28.01.2011 had approved the proposal for filling up of 18 vacant posts of Assistant Professors in 11 disciplines and directed the Dean i/c for necessary follow up action. Accordingly, Recruitment Notification was given in the HINDU News Paper on 23.03.2011 with the approval of the Chief Secretary and Chairperson of PAJANCOA (Karaikal) Society, based on the old Recruitment Rules approved by the XXII Governing Body of PAJANCOA&RI. The last date given for receiving the application was 20.04.2011. The roster as suggested by the Dept.of Personnel and Administrative Reforms (Enforcement Cell) was strictly followed. In the meantime, notification for conducting election for Puducherry Legislative Assembly in 2011 was notified on 10.30.2011. Subsequently, action was taken up to recruit the regular Dean for PAJANCOA&RI. Hence, there was delay in the recruitment process. The regular Dean Dr.V.Chellamuthu assumed the charge on 23.08.2011 and he arranged to process the applications and to conduct interview, based on the revised UGC regulations 2010 as well as the new revised RR as approved by the 40th meeting of Governing Body held on 16.02.2012.

Totally 102 applications were received. Out of them, 84 were found elgibile and 18 were found not eligible. The interview was held on 15.03.2012. Out of the 18 posts called for (OC-10, SC-4, ST-3 and PH-1) eligible candidates were available only for 14 posts and eligible candidates were not available for 4 posts (ST-1 & PH-1 in Agrl.Economics, SC-1 in Crop Physiology and ST-1 in Physical Education) and hence 4 vacancies arose. Candidates were selected by the duly constituted selection committee as per the norms of new UGC regulations 2010 and appointment orders were issued on 21.03.2012. All the 14 candidates, as listed below, have joined as Assistant Professors at PAJANCOA&RI.

The Governing Body is requested to ratify the selection and appointment of 14 Assistant Professors at PAJANCOA&RI in 2012.

12.Agenda Item No.12 of XXXXI meeting:

TO CONSIDER AND APPROVE THE IMPLEMENTATION OF THE CAREER ADVACEMENT SCHEME (CAS) FOR THE TEACHING STAFF MEMBERS OF PAJANCOA&RI.

The PAJANCOA&RI is following the recommendations of the University Grants Commission (UGC) for pay fixation, direct recruitment and Career Advancement Scheme (CAS) for the teaching staff. The new pay scales as per the UGC norms based on the recommendation of Sixth Central Pay Commission was implemented for the teaching staff of PAJANCOA&RI from March 2009, giving retrospective effect from 01.01.2006 after getting the approval in the 38th meeting of the Governing Body held on 23.02.2009.

As far as the Career Advancement scheme (CAS) for the teaching staff of PAJANCOA&RI was concerned, it was decided to follow the TNAU norms, as approved in the 39th Governing Body of PAJANCOA&RI held on 28.01.2011.

Till October 2012 the TNAU did not issue any guidelines for CAS based on New UGC guidelines 2010. However, it was understood that the TNAU has implemented CAS for its teaching faculties in November 2012. Therefore, the Dean had addressed to the Registrar, TNAU, Coimbatore, <u>vide</u> letter No.Dean/PJN/Estt./Career Advancement/2012-13, dt. 09.11.2012 requesting for guidelines to conduct CAS for the teaching staff of PAJANCOA&RI as per TNAU norms. The TNAU has sent the guidelines for the CAS vide Lr.No.R3/4047/PAJANCOA/2012, dated 20.12.2012 and the same was submitted to the Chief Secretary and Chairperson through the Secretary (Agriculture) for approval vide Note No.PJN/Dean/CAS/Teaching staff /2012, dt.03.01.2013. The Secretary (Agriculture) asked for details of financial implication. The file was again re-submitted with details of financial implications on 08.04.2013. Subsequently, the file was returned to the Dean with the following queries by the Chief Secretary – cum – Chairperson.

- 1. Why not implement CAS prospectively?
- 2. Whether the case filed by some of the teaching staff have a bearing on this proposal of implementation of CAS?
- 3. Action taken by PAJANCOA&RI to generate own revenue.

The file was resubmitted by the Dean to the Chief Secretary-cum-Chairman, through the Secretary to Govt.(Agriculture) with relevant details for the said three queries, on 21.06.2013. Decision of the Chief Secretary – cum-Chairman in this regard is awaited.

The Governing Body is requested to consider and approve this proposal and permit the Dean to implement the CAS, following due procedures as given in the TNAU/UGC guidelines 2010 for the teaching faculty members of PAJANCOA&RI.

13. Agenda Item No.13 of XXXXI meeting:

TO CONSIDER THE REPRESENTATION OF DR.A.POUCHEPPARADJOU AND DR.R.SANKAR FOR THE CAREER ADVANCEMENT SCHEME(CAS).

The two Associate Professors viz., Dr.A.Pouchepparadjou and Dr.R.Sankar are among the fourteen Agricultural Officers who first served in the Department of Agriculture, Govt.of Puducherry and later on got deputed to

PAJANCOA&RI and subsequently got absorbed as Assistant Professors. The said fourteen Agricultural officers turned Assistant / Associate Professors obtained a G.O.Ms.No.22/Ag. Dated 10th October 2005 for counting their past services in the Department of Agriculture for promotion from the cadre of Associate Professors to the cadre of Professor at PAJANCOA&RI.

Among the fourteen Agricultural Officers turned Professors, eleven of them were the beneficiaries of the G.O.Ms.No.22/Ag dated 10.10.2005, who were promoted from the cadre of Associate Professor to Professor. However, the two Associate Professors viz., Dr.A.Pouchepparadjou and Dr.R.Sankar were not the beneficiaries due to lack of 17 years of service at the time of the first interview held on 31.08.2006 and the second interview held on 28.02.2008.

The said G.O.Ms.NO.22/Ag. Dt 10.10.2005 was challenged by the directly recruited Professors in the High Court of Madras (W.P.No.5219 and 6336 of 2006). The G.O.Ms.No.22 was set aside by the judgment of the Single Judge. The eleven of the Agricultural Officers turned Professors who were beneficiaries of G.O.Ms.No.22 have appealed in the two members Division Bench of High Court against the judgment of the Single Judge (M.P.No.1 of 2009 in W.A.1468/2009).

The writ appeals were dismissed and the judgment of Single Judge setting aside the G.O.Ms.No.22 was upheld by the two members Division Bench.

Subsequently only seven out of the eleven Agricultural Officers turned Professors appealed in the Supreme Court, New Delhi (Special Leave petition NO.33338 – 33339 of 2011) against the judgment of Division Bench of the High Court of Madras and four of the Agricultural Officers turned Professors viz., Dr.R.Sankar, Dr.A.POuchepparadjou, Dr.K.Omar Hattab and Dr.R.Govindarasu (former two were non-beneficiaries and later two were beneficiaries of the G.O.Ms.No.22) were shown as Performa Respondents (formal respondent who is not interested in the subject matter but may be a Govt. authority who is to be bound by the Court orders and outcome of the case).

Though Dr.R.Sankar and Dr.A.Pouchepparadjou were not the beneficiaries of the G.O.Ms.No.22, they were shown as Performa respondents in the Special Leave Petition of the Supreme Court.

The Dean is taking action to conduct the CAS for the faculties of PAJANCOA&RI as per the new UGC Guidelines 2010. Hence the two Associate Professors (Dr.R.Sankar and Dr.A.Pouchepparadjou) have represented that they may be considered for the CAS by giving an undertaking in a stamped paper (Indian Non-judicial) that they have not enjoyed any benefit from the G.O.Ms.No.22, though they were the respondents in the Writ petitions and writ appeals in the High Court of Madras and they are not party to the Special Leave Petition filed in the Supreme Court of India as they are only Performa respondents. They also stated in their undertaking that they abide by the judgement dated 12.09.2011 of the Division Bench of the High Court of Madras that set aside the G.O.Ms.No.22.

It is also submitted that if the requests of the Dr.A.Pouchepparadjou and Dr.R.Sankar, Associate Professors are considered for Career Advancement Scheme (CAS) pending the disposal of the Special Leave Petition (SLP) and based on their undertakings, given in the stamped paper, there are chances that other performa respondents who are not party for SLP but were beneficiaries of the G.O.Ms.NO.22 (got promoted as Professors already) may also take recourses to the CAS to be conducted for the post of Professors notwithstanding the final outcome of the SLP at the Supreme Court of India.

In the light of the above details, as directed by the Chief Secretary – cum – Chairperson, the proposal / representation is placed before the Governing Body. The Governing Body is requested to consider this proposal and give an appropriate direction to the Dean. 14. Agenda Item No.14 of XXXXI meeting:

TO CONSIDER AND GIVE APPROPRIATE DIRECTION FOR THE UNAUTHORISED ABSENCE FROM DUTY BY DR.A.SHAIK ALAUDDIN, PROFESSOR (AGRICULTURAL EXTENSION), PAJANCOA&RI.

Dr.A.Shaik Alauddin was in the habit of availing EL/EOL frequently for going to Singapore on the pretext of taking care of his ailing parents-in-law or looking after his family members. He had availed 729 days of leave (EL/EOL) during the past ten years from 1991 to 2011 to be at Singapore. He was charge sheeted twice for his overstayal abroad and unauthorized absence from duty without proper permission from the competent authority. For the first occasion of unauthorized absence of 33 days from 17.09.2001 to 12.10.2001, an enquiry was conducted. Due to some administrative lapses, the charges could not be proved and he was exonerated. On the second occasion he was charge sheeted for his overstayal of leave from 15.05.2004 to 02.08.2005 (one year and two and a half months abroad at Singapore). The charges were proved and minor penalty was imposed. The penalty was reduction to a lower stage in the time-scale of pay by one stage for a period of two years, without cumulative effect and not adversely affecting his retirement benefits, under Rule 11(iii) (a) of CCS (CCA) Rules, 1965.

Now, Dr.A.Shaik Alauddin is again on unauthorized absence from duty with effect from 04.06.2012 and gone to Singapore without proper permission / sanction of leave by the Competent Authority.

Dr.A.Shaik Alauddin requested for permission to register on-line for a course at Singapore and also requested for study leave and other eligible leave for two years (E.L.from 1.5.2012 for two months and EOL for two years). As he was given study leave to do his Ph.D. course work for one year during 1994-1995 (27.06.1994 to 26.06.1995) with full pay and allowances, he was refused the requested leave. The Chief Secretary and Chairperson directed him to report for duty on 01.07.2012. However he again applied for EL from 04.06.2012 to 10.08.2012 and gone to Singapore. The Dean refused the leave and sent a Memorandum dated 28.06.2012 directing him to join duty

on 01.07.2012 as per the direction of the Chief Secretary and Chairperson. Since Dr.A.Shaik Alauddin did not report for duty from 04.06.2012 (He applied for EL from 04.06.2012 to 28.08.2012 but leave was not sanctioned), the Dean sent an another Memorandum dated 29.08.2012, directing him to submit his explanation as to why disciplinary action should not be taken against him for his unauthorized absence.

Instead of giving an explanation to the Dean, Dr.A.Shaik Alauddin had filed a case from Singapore at the High Court of Madras vide W.P.No.25036/2012 against PAJANCOA&RI administration and the respondents in this case are (i) the Chief Secretary and Chairperson, PAJANCOA (Karaikal) Society and (ii) the Dean, PAJANCOA&RI. He had prayed for quashing the Memorandum dated 28.06.2012 of the Dean which directed Dr.A.Shaik Alauddin to join duty on 01.07.2012 by refusing the EL requested by him from 04.06.2012. Mr.M.T.Arunan, Advocate at Chennai was engaged to defend the case on behalf of the PAJANCO&RI administration, with the approval of the Chief Secretary and Chairperson. Dr.A.Shaik Alauddin's frequent visit to Singapore for his personal work only shows that Dr.A.Shaik Alauddin has no devotion to his duties.

Subsequently, the Dean submitted a file to the Chief Secretary – cum-Chairperson on 22.11.1012 requesting for direction to initiate disciplinary proceedings against Dr.A.Shaik Alauddin notwithstanding the case (W.P.No.25036/2012) at the High Court of Madras. The file was sent to Special Secretary (DP&AR), Puducherry for his advice. The file was returned to the Dean by the Department of Personnel and Administrative Reforms through the Under Secretary to Govt. (Agriculture) asking for additional details such as the Writ petititon and the counter affidavit filed by the Dean. The file was re-submitted by the Dean on 02.04.2013 to the Secretary to the Govt.(Agriculture) with the writ petition and the counter affidavit of the Dean. A decision on the file in this regard is awaited to proceed further.

In the light of the above details, the Governing Body is requested to consider this agenda and give appropriate direction to the Dean to proceed further. 15.Agenda Item No. 15 of XXXXI meeting:

TO CONSIDER THE COURT CASES AND SUSPENSION OF Dr.S.ANANDKUMAR, ASSOCIATE PROFESSOR (AGRICULTURAL EXTENSION), PAJANCOA&RI.

Dr.S.Anandkumar was in the habit of coming late to office. The Dean (Dr.V.Chellamuthu) gave a letter dated 12.12.2011 advising Dr.S.Anandkumar to come to the office in time. As a retaliatory act, Dr.S.Anandkumar sent lot of petitions to various authorities and Hon'ble Ministers stating that there was lot of corruption in the selection of Dr.V.Chellamuthu as the Dean. For all his allegations proper reply was given stating that the Dean was selected by merit by a duly constituted Selection Committee appointed by the Govt.of Puducherry. Dr.S.Anandkumar was again unduly alleging that there was corruption in the selection of Dean and the Govt. is not taking action against Dr.V.Chellamuthu. Dean. Therefore a warning was issued to Dr.S.Anandkumar by the Dean as per the direction of the Chief Secretary and Chairperson advising him not to indulge in anti-Govt. agitation vide Memorandum dated 21.03.2012.

Dr.S.Anandkumar is in the habit of filing cases against his superior officers even for trivial issues. For instance, he had filed a writ petition in the High Court of Madras(W.P.No.9449/2012, dated 03.04.2012) to quash the above said Memorandum dated 21.03.2012.

Dr.S.Anandkumar was also given a warning through a Memorandum dated 29.06.2011 by the then Collector-cum- Dean for temporary misappropriation of office money (Rs.84,500/-). He filed a case in the High Court of Madras (W.P.No.24467/2009, dated 30.11.2009) praying for quashing the said Memorandum dated 29.06.2011.

Dr.S.Anandkumar availed Special Casual Leave for four days for attending activities as a Team Builder of India Against Corruption Movement, which is inadmissible as per CCS(Leave) Rules 1972. Hence the four days Special Casual Leave was treated as unuthorised absence and an order was issued to recover four days salary <u>vide</u> Memorandum dated 06.09.2012. He filed a case in the High Court of Madras (W.P.No.25390/2012 dated 13.09.2012) for staying the order of recovery of salary.

Dr.S.Anandkumar was requested to shift his office and the Audio Visual Laboratory (A.V.Lab.) which was under his custody, for expanding the examination hall. He was given alternate place. The whole Department of Agricultural Economics and Agricultural Extension obliged the order of Dean for shifting their office to 'C' block from 'A' block and Administrative Block, except Dr.S.Anandkumar. Hence Dr.S.Anandkumar was suspended with effect from 17.09.2012. After his suspension, his office room and A.V.Laboratory were shifted after taking an inventory and videography, by a committee constituted for this purpose, in presence of a Tahsildar and Executive Magistrate on 24th and 25th September 2012.

Dr.S.Anandkumar had filed a case at Principal District Munsif Court of Karaikal (O.S.No.425/2012) praying for permanent injunction against the Memorandum dated 29.08.2012 that directed him to shift his office and A.V.Laboratory. Subsequently, he also filed a case (W.P.No.26304/2012) at the High Court of Madras praying for staying the order of suspension.

Except the case in W.P.No.24467/2009, dated 30.11.2009 that was related to temporary misappropriation of office money (which was withdrawn later by Dr.S.Anandkumar after repaying the money to office), all the other four cases are pending in the court.

The order of suspension of Dr.S.Anandkumar was reviewed on 05.12.2012 by the Review Committee constituted for the said purpose by the Governing Body on circulation agenda. The committee consisted of the Chief Secretary to the Government and the Chairperson, Secretary to the Government (Agriculture) and the Dean, PAJANCOA&RI. The review committee decided to extend the order of suspension for another 180 days with effect from 16th December 2012. Accordingly, the Dean was directed to issue an order. The Dean issued the order on 06.12.2012 by extending the order of suspension for further period of 180 days with effect from 16th December 2012. The deadline f 180 days falls on 13th June 2013 (Thursday).

The Review Committee also directed the Dean to issue charge sheet immediately to the suspended officer. As directed by the Review Committee, the charge sheet was issued to the charged officer on 08.12.2012.

Dr.S.Anandkumar has denied all the charges in toto vide his letter No.Nil. dated 21.12.2012 and also stated that the matter is subjudice before Hon'ble High Court of Madras and requested to drop the disciplinary proceedings against him. Since Dr.S.Anandkumar denied the charges, it necessitated institution of an inquiry against him.

Thiru J.Ashok Kumar, I.A.S, the District Collector of Karaikal was appointed as Inquiry Authority and Tmt. S.Meenakshi, Junior Accounts Officer, Office of the Deputy Director of Accounts & Treasuries, Karaikal was appointed as Presenting Officer by the Chief Secretary – cum – Chairperson. All the related documents in connections with the enquiry were made available to the Inquiry Authority and the presenting officer vide letter No.PJN/Deam/E1/shifting of A.V.Lab./2012 dated 08.03.2013. The first preliminary hearing of the case was fixed on 10th may 2013. However, the first hearing was not conducted as scheduled on 10th May 2013 as Dr.S.Anandkumar had obtained an interim stay order (M.P.No.1/2013 in W.P.No.13920 of 2013) from the Hon'ble High Court of Madras on 8th May 2013 against the order of appointment of Mr.J.Ashok Kumar, I.A.S. as Inquiry Authority vide Order No.PJN/Dean/E1/Shifting of A.V.lab./2012(ii) dated 21.02.2013 of the Chief Secretary -cum - Chairman of PAJANCOA (Karaikal) Society. The stay was granted for a period of six weeks (i.e., upto 19th June 2013). The Charged officer got the stay order on flimsy grounds, by stating that he had already filed a complaint dated 12.01.2013 before the Appellate Authority under RTI Act, 2005 against the District Collector.

The Dean is taking action to vacate the interim order of stay by engaging a private advocate Thiru Manisundar Gopal, ith the permission of the Chief Secretary –cum-Chairman of PAJANCOA (Karaikal) Society. In the meantime, the order of extension of suspension of Dr.S.Anandkumar was going to expire on 13th June 2013. Hence, the second meeting of the Review Committee was held on 30.05.2013 to review the order of extension of suspension of Dr.S.Anandkumar. The suspension Review Committee had decided to extend the order of suspension of Dr.S.Anandkumar for another 180 days with effect from 14th June 2013 (i.e., upto 10th December 2013). Accordingly, an order of extension of suspension was issued to Dr.S.Anandkumar on 03.06.2013 by the Dean.

In the light of the above background, the Governing Body is requested to consider this agenda and give appropriate direction to the Dean to proceed further in this regard.

16. Agenda Item No. 16 of XXXXI meeting:

TO CONSIDER THE COURT CASES AND SUSPENSION OF THIRU S. NAGARAJAN, AGRICULTURAL MAZDOOR, PAJANCOA&RI.

Thiru S.Nagarajan, Agricultural Mazdoor is in the habit of either not attending the allotted farm work by the Farm Managers or failing to carry out the allotted work by creating an environment for altercation with the supervisory officials viz., FieldMan/Field Assistant and Farm Managers. He has been working at PAJANCOA&RI since 04.01.1991 as Daily Rated Seasonal Agricultural Labourer (i.e., engaged as agricultural labourer on daily wages as and when needed.) Subsequently, he was absorbed and regularized on 30.08.2011 as Agricultural Mazdoor.

Before regularization as Agricultural Mazdoor, he has been working in the Agronomy farms. After regularization, he was transferred to the Department of Horticulture farms. From there, his services were spared to Mushroom Unit (Laboratory unit of Dept.of Plant Pathology) based on his oral request. However, due to some problem in the Mushroom unit, he was brought back to the Horticulture farms on 07.01.2008. As he created some problem in the farms of Horticulture, he was transferred to farms of Department of Agronomy on 03.12.2008. Since he was instigating other labourers, he was again transferred to farms of Horticulture on 26.12.2012 from Agronomy Department.

Thiru S.Nagarajan had refused to attend physically the allotted work by the Farm Manager since 28.01.2013 and he used to sign in the attendance register and roam around the campus without attending allotted work, as reported by the Farm Manager as well as the Professor and Head, Dept.of Horticulture, PAJANCOA&RI

Therefore, the Dean had called for an explanation from Thiru S.Nagarajan, <u>vide</u> Memorandum even No.PJN/Estt./E2/Memo/2012-13, dated 31.01.2013, 05.02.2013, 26.02.2013 and 18.03.2013. He was also instructed to obey the orders of the higher authorities and attend the allotted work through the said Memorandum. He did not attend the allotted work, did not obey the order of the Dean and did not furnish any explanations to the Memorandum.

Hence, treating the period of no work as dies-non, the salary was not claimed for the days he had not physically attended the allotted work. Instead of giving explanations as well as obeying the orders of the Dean, Thiru S.Nagarajan approached the Hon'ble High Court of Madras and filed a Writ petition (W.P.No.6607/2013) against the PAJANCOA&RI administration, with the following two prayers viz.,

- To quash the memorandum No.PJN/Estt./E2/memo./2012-13, dt.26.02.2013 of the Dean, which called for explanation from the said Agricultural mazdoor.
- (ii) To regularly pay the salary and allowances to the petitioner.

The Dean is the sole respondent in this case. The court in its interim order dated 20.03.2013 directed the respondent (Dean) to pay the salary due to the petitioner (Agrl. Mazdoor) for the months of January and February 2013. The Dean appealed against the interim order by engaging Mr.M.T.Arunan, Advocate, Chennai, with the approval of the Chief Secretary – cum – chairperson, PAJANCOA (Karaikal) Society. In the mean time the Dean issued a show-cause notice No.PJN/Estt./E2/Show cause notice/2012-13, dt.03.04.2013 to Thiru S.Nagarajan as to why disciplinary action should not be taken against him for his disobedience and violation of CCS (Conduct) Rules 1964. Again the Court Order dated 02.04.2013 of W.P.No.6607 of 2013 and M.P.Nos. 1 and 2 of 2013 directed the respondent Dean to pay the salary to the petitioner in full for the period during which he signed the attendance register for the previous months. The court also observed that if the respondent feels that the petitioner is guilty of any misconduct, it is open to the respondent to take any action in accordance with law.

Therefore, the Dean suspended Thiru S.Nagarajan, Agricultural Mazdoor with effect from 12th April 2013 and initiated disciplinary proceedings, with the knowledge of the Secretary (Agriculture) and the Chief Secretary – cum – Chairperson.

The Dean again appealed against the Court order dated 02.04.2013 of the Hon'ble Mr.Justice V.Ramasubramanian by engaging the advocate Thiru M.T.Arunan.

As a next step, charge sheet was issued to Thiru S.Nagarajan, Agrl. Mazdoor (under suspension) <u>vide</u> Memorandum dated 27.05.2013. Since the said Agricultural Mazdoor has denied all the four charges framed against him, thee was a need to conduct oral enquiry. As the 90th day of suspension was to expire on 10th July 2013, the first meeting of the suspension Review Committee was convened on 03.07.2013 at 4.00 p.m. in the chamber of the Chief Secretary – cum – Chairman, PAJANCOA (Karaikal) Society. The Review Committee as approved by the Governing Body on circulation agenda consisted of (1) the Chief Secretary – cum – Chairman of PAJANCOA (Karaikal) Society, (2) Secretary to the Govt.(Agriculture) and (3) the Dean, PAJANCOA&RI. The Review Committee has decided to extend the order of

suspension of Thiru S.Nagarajan, Agrl. Mazdoor (under suspension) for another 90 days with effect from 11th July 2013.

The Review Committee also advised the Dean to pass an order of extension of suspension accordingly, arrange to conduct and complete the enquiry proceedings in a time bound manner and also to submit the facts properly before Hon'ble High Court during the hearing of appeal case.

The Chief Secretary – cum – Chairman, PAJANCOA (Karaikal) Society has approved the appointment of Board od Inquiry. Inquiring Authority consisting of two Heads of Departments viz., (1) Dr.K.Paramasivam, Professor and Head, Department of Plant Breeding and Genetics and (2) Dr.A.Baskar, Professor and Head, Department of Soil Science and Agricultural Chemistry of PAJANCOA&RI. The Chief Secretary – cum – Chairman has also approved the appointment of Thiru R.Sowrirajan, Superintendent, Office of the Dean, PAJANCOA&RI as the Presenting Officer.

The Governing Body is requested to ratify the appointment of two member Board of Inquiry/Inquirying Authority and Presenting Officer to inquire into the charges framed against Thiru S.Nagarajan, Agricultural Mazdoor (under suspension)

The Governing Body is also requested to take note of the developments and give necessary directions to the Dean.

17. Agenda Item No. 17 of XXXXI meeting:

TO RATIFY THE AUTHORITIES COMPETENT TO INITIATE DISCIPLINARY PROCEEDINGS AND IMPOSE PENALTIES IN RESPECT OF EMPLOYEES OF PAJANCOA&RI.

The Competent authorities to initiate disciplinary proceedings and impose penalties in respect of various cadres of employees of PAJANCOA&RI as per CCS (CCA) Rules and CCS (Conduct) Rules was approved vide Note No.1/PJN/E1/2001-02 dated 13.12.2001, by the then Chief Secretary – cum – Chairman in 2001. The same is being followed since then.

The content of the Note dated 13.12.2001 is reproduced as such below for ratification / approval by the Governing Body.

The Governing Body is requested to ratify the disciplinary actions taken in the past since 2001 by the various competent authorities as per the above approved note dated 13.12.2001 as well to approve the authorities prescribed in the note as competent authorities to initiate disciplinary proceedings and impose penalties, in respect of employees of PAJANCOA&RI in future also, as per CCS(CCA) Rules and CCS(Conduct) Rules in force from time to time since the PAJANCOA (Karaikal) Society is following the CCS Rules as it is yet to finalise bye-law of its own.
18. Agenda Item No. 18 of XXXXI meeting:

TO CONSIDER AND APPROVE THE CONSTITUTION OF REVIEW COMMITTEE FOR REVIEWING THE ORDER OF SUSPENSION OF SUSPENDED EMPLOYEES OF PAJANCOA&RI.

As per Rules 10 of CCS (CCA) Rules, 1965 and Sub-rule (7) an order of suspension made or deemed to have been made under sub-rule (1) or (2) shall not be valid after a period of ninety days unless it is extended after a review, for a further period before the expiry of ninety days.

The sub rule (6) states that the review of order of suspension has to be done on the recommendation of a Review Committee constituted for the purpose and pass orders either extending or revoking the suspension. Subsequent reviews shall be made before expiry of the extended period of suspension.

Therefore a Review Committee consisting of the following members was formed to review the order of suspension of Dr.S.Anandkumar, Associate Professor (Agrl. Extension), who was suspended with effect from 17th September 2012.

 The Chief Secretary – cum – Chairperson, PAJANCOA (Karaikal) Society
 The Secretary to Govt.(Agriculture)
 The Dean PAJANCOA&RI, Karaikal.
 Chairperson of the Review Committee
 Member of the Review Committee
 Member-Secretary of the Review Committee.

The constitution of the Review Committee with the above three members was approved by the Governing Body members through circulation agenda dated 05.11.2012 circulated by the Member-Secretary.

The first meeting of the review committee was held on 5th December 2012 to review the order of suspension of Dr.S.Anandkumar, Associate Professor (Agrl. Extension), PAJANCOA&RI. Subsequently, the second meeting of the Review Committee met on 30.05.2013 to review the order of

suspension of Dr.S.Anandkumar. Necessity may arise in future for such reviews in respect of other categories of employees of PAJANCOA&RI.

Therefore, the Review Committee consisting of the Chief Secretary – cum – Chairperson of PAJANCOA (Karaikal) Society, Secretary to Govt.(Agriculture and the Dean, PAJANCOA&RI, may be empowered by the Governing Body to review the order of suspension of different categories of employees of PAJANCOA&RI.

The Governing Body is requested to consider and approve the above proposal.

19. Agenda Item No.19 of XXXXI meeting:

TO RATIFY THE ACTION TAKEN ON THE IMPLEMENTATIOIN OF THE MODIFIED ASSURED CAREER PROGRESSION SCHEME (MACPS) TO THE NON-TEACHING EMPLOYEES OF PAJANCOA & RI., KARAIKAL.

Government of Puducherry has implemented the Modified Assured Career Progression Scheme (MACPS) to the civilian employees of Government of Puducherry w.e.f. 01.09.2008 vide G.O. Ms. No.84 dated 26.08.2009 of the Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry. The MACPS envisages three financial upgradation to the employees in 10, 20 and 30 years of continuous service. The service Association has demanded the implementation of the MACPS to them so that they will get the financial upgradation on completion of 10, 20 and 30 years of continuous service which will mitigate their grievance of stagnation of regular promotions.

As such, proposals were submitted to the Chairman-cum- Chief Secretary to Government, Puducherry for the grant of Financial Upgradation under MACPS to the eligible Non-Teaching Employees of PAJANCOA & RI., Karaikal and got approval of the Chairman and Screening Committee/DPC. Accordingly, 40 employees were granted Financial Up gradation under MACPS and an amount of Rs. 13.00 Lakhs were paid as arrears of pay and allowances to the employees.

Therefore, the Governing Body is requested to ratify the action taken on the implementation of the MACPS to the Non-Teaching Employees of PAJANCOA & RI., Karaikal.

20. Agenda Item No.20 of XXXXI meeting:

TO CONSIDER AND APPROVE THE PROPOSAL FOR THE GRANT OF FINANCIAL UPGRADATION UNDER THE MODIFIED ASSURED CAREER PROGRESSION SCHEME (MACPS) TO THE NON-TEACHING EMPLOYEES OF PAJANCOA & RI., KARAIKAL WHO HAVE COMPLETED 10, 20 AND 30 YEARS OF CONTINUOUS SERVICE AS ON DATE.

Government of Puducherry has implemented the Modified Assured Career Progression Scheme (MACPS) to the civilian employees of Government of Puducherry w.e.f. 01.09.2008 vide G.O. Ms. No.84 dated 26.08.2009 of the Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry. The MACPS envisages three financial upgradation to the employees in 10, 20 and 30 years of continuous service. The service Association has demanded the implementation of the MACPS to them so that they will get the financial upgradation on completion of 10, 20 and 30 years of continuous service which will mitigate their grievance of stagnation of regular promotions.

There are 20 non-teaching employees who have completed 10, 20 and 30 years of continuous service and eligible for the grant of Financial Upgradation under MACPS. An amount of Rs. 5.00 Lakhs is the financial implication for the grant of Financial Upgradation under MACPS to the employees from the date on which they complete the 10, 20 and 30 years of service.

Hence, the Governing Body may consider and approve the proposal for the grant of Financial Upgradation under MACPS to the non-teaching employees as and when they complete 10, 20 and 30 years of continuous service at PAJANCOA&RI.

21. Agenda Item No. 21 of XXXXI meeting:

TO CONSIDER AND APPROVE THE PROPOSAL FOR THE FILLING UP OF ONE POST OF DRIVER GR.III BY PROMOTION FROM THE POST OF CLEANER.

There is one post of Driver LMV Grade III in the scale of pay of Rs. Rs.3050-75-3950-80-4590 which was created vide Agenda item No.15 of the XVI Meeting of Governing Body held on 23.01.1996. The posts of Driver Grade III remains vacant from the date of creation as detailed below:

Total cadre strength of Driver LMV Gr.III -	3 posts
No. of post exists -	2 posts
No. of post vacant -	1 post.

As per the Recruitment Rules for the post of Driver Gr.III, the method of Recruitment is as follows:

1) By Direct Recruitment	: 66 2/3%
2) By Promotion	: 33 1/3%

Out of three posts, two posts of Driver Gr.III were filled up by regularization of daily rated staff under Direct Recruitment Quota. Therefore, remaining one post of Driver is to be filled up under promotion quota. The qualification as per the RR is recapitulated below:

Educational Qualification	:	1. A Pass in VIII Std., and possessing
for Promotion		Driving License.
		2. Not less than 2 years experience in Driving of
		LMV.

The Employees Association and Cleaners frequently request the Administration to fill up the vacant post atleast by promotion. The matter was referred to the Governing Body indicating the existing vacancy and to fill up the post from the Cleaner having all requisite qualifications as per the Recruitment Rules of Drivers. Since the three incumbents are not having the required educational qualifications, a relaxation regarding the educational qualification was sought for.

Therefore, the XXXVII Meeting of the Governing Body held on 16.04.2007 vide Agenda Item No.22 relaxed the Educational qualification from VIII standard to V Standard for filling up the post under promotion quota. It was also decided that the existing Cleaners have to undergo a Trade Test for Promotion.

The existing three Cleaners have completed 12 years of service and no other avenue of promotion is available for them. Hence they could be considered for the post of Driver Gr.III only. In addition, there is no financial commitment or additional financial implications in filling up of vacant post of Driver Gr.III (LMV) by promotion from the post of Cleaner since the existing Cleaners were granted 1st Financial Up gradation under MACP.

Hence, the Governing Body may kindly consider and approve the proposal for the filling up of one vacant post of Driver Gr.III (LMV) by promotion from the post of Cleaner based on seniority. The resultant vacancy of Cleaner post will <u>not</u> be filled up.

22. Agenda Item No. 22 of XXXXI meeting:

TO RATIFY THE ACTION TAKEN ON THE IMPLEMENTATION OF SCHEME ON COMPASSIONATE APPOINTMENT OF DEPENDENTS OF DECEASED EMPLOYEES OF PAJANCOA & RI, KARAIKAL.

Government of Puducherry provide the compassionate appointment to widows (or) sons (or) daughters of a Govt. servant who dies in harness including death by suicide, leaving his family in immediate need of assistance when there is no other earning member in the family. As per Memorandum No.14014/6/95-Estt(D) of the Department of Personnel and Training, Govt. of

India dated 26.09.1995, the compassionate appointment can be made up to a maximum of 5% of vacancies falling under direct recruitment quota in any Group 'C' and Group 'D' posts. In order to implement the scheme of compassionate appointment in the PAJANCOA & RI, Karaikal, an Agenda was placed before the XXXVIII Governing Body held on 23.02.2010 vide Agenda Item No.24. The Governing Body felt that it is not possible to have a specific scheme of compassionate appointment of dependents of deceased employees of autonomous institution like PAJANCOA & RI in view of practical difficulties in earmarking the 5% of the vacancies. However, the Governing Body directed the Dean, PAJANCOA & RI, Karaikal to submit individual cases for consideration on merit.

Accordingly, proposals were submitted to the Chairman-cum- Chief Secretary to Government, Puducherry for the compassionate appointment in the PAJANCOA & RI, Karaikal in respect of the individual requests received from Tmt. R. Sathiya W/o. (late) Thiru. K. Ramachandiran, Peon and Tmt. B. Nirmala, W/o. (late) Thiru. R. Balasaravanan, Work Assistant. The Chairman - cum -Chief Secretary to Govt., Puducherry has approved the proposal for the appointment of the two individuals on compassionate grounds to the vacant posts of Lower Division Clerk. The two individuals have joined in the PAJANCOA & RI, Karaikal as Lower Division Clerk on compassionate grounds on 08.11.2012 and 09.11.2012 respectively.

Therefore, the Governing Body is requested to ratify the action taken on the filling up of vacant posts of Lower Division Clerk on compassionate grounds in PAJANCOA & RI., Karaikal.

23. Agenda Item No. 23 of XXXXI meeting:

TO CONSIDER THE REQUEST OF SOME OF THE PROFESSORS FOR RELEASE OF WITHHELD ANNUAL INCREMENTS IN VIEW OF PENDING CASE AT THE HON'BLE SUPREME COURT OF INDIA.

At the time of inception of this Institution, 14 Agricultural Officers came on deputation to PAJANCOA from the Department of Agriculture on various dates and subsequently got absorbed as Assistant Professors. They obtained a G.O.Ms.No.22/Ag. Dated 10.10.2005 to count their past services as Agricultural Officer in the Agricultural Department, Government of Puducherry for promotion to the post of Professors at PAJANCOA & RI. Out of them, the following eleven Associate Professors were promoted as Professors under Career Advancement Scheme, conducted on 31.08.2006 and 28.02.2008.

- 11. Dr. D. Adiroubane

The said G.O. Ms. No.22/Ag Dt.10.10.2005 was challenged in W.P.5219/2006 & 6336/2007 by the directly recruited Professors in the Hon'ble High Court of Madras, as they will become juniors to them by counting their past services in the Department of Agriculture.

The judgment of the single judge on the above writ petitions has set aside the G.O. Ms. No.22/Ag Dt.10.10.2005. As a first step towards implementing the judgement, the then Collector-cum-Dean, PAJANCOA & RI withheld the annual increment w.e.f. 01.07.2009.

Subsequently, nine Professors and two Associate Professors, who were absorbed from the Department of Agriculture, challenged the judgement of the single judge through writ appeals No.1467 & 1468/2009 Dt.17.03.2010. The writ appeals were taken up by two members Division Bench of the High Court of Madras. The two members Division Bench gave an interim order of stay of the operation of the Judgment dt.30.04.2009 of the Single Judge vide its order dated 26.03.2010. Based on the above interim order of stay, the Professors requested for grant of annual increment. However, in the final order, the Division Bench dismissed the writ appeals and set aside the G.O. Ms. No.22 Dt.10.10.2005.

Out of the said nine Professors, only seven Professors again appealed against the judgement dated 12.09.2011 of the two member Division Bench of Hon'ble High Court of Madras on 19.11.2011 at the Hon'ble Supreme Court of India through a petition for Special Leave to Appeal (civil) No.33338 -33339 of 2011.

The Hon'ble Supreme Court of India passed an interim order "*to maintain status quo*". It means the status before the Special Leave Petition has to be maintained. That is the operation of the judgment of the Division Bench alone was stayed and the validity of G.O. Ms. No.22/Ag. Dated 10.10.2005 has not been upheld. Therefore the annual increment that was withheld with effect from 01.07.2009, based on the judgment of Single Judge in W.P.5219/2006 & 6336/2007 is still continued.

Moreover, the A.G Audit, Puducherry in their Audit Para No.PBS-I /2/IR-150/2009-10 dated 20-10-2010, objected the promotion to the post of Professor vide G.O.Ms.No.22, and pointed out that the promotion was not in consonance with the UGC guidelines for Career Advance Scheme, and directed to effect the recovery of excess payment due to incorrect adoption of Career Advancement Scheme.

Subsequently, the whole spectrum of the cases related to the G.O. Ms. No.22/Ag. Dated 10.10.2005 was placed by the Dean in the 40th Meeting of the Governing Body of PAJANCOA (Karaikal) Society held on 16.02.2012 as Agenda Item No. 20: Any other item (Table Agenda). After a detailed discussion, the Governing Body directed the Dean, PAJANCOA & RI to wait for the outcome of the final judgment of the Hon'ble Supreme Court of India. Till date, the case is pending at the Supreme Court of India.

If the Supreme court issues orders in favour of the Professors, reversion to original posts and recovery of overpayment of pay and allowances does not arise. Otherwise if the court orders are not in their favour, reversion to original posts of Associate Professor and recovery of overpayment of pay and allowances will be in force. In order to minimize the quantum of overpayment the periodical increment is withheld till date. Whereas, professors promoted based on the G.O.Ms.No.22/Ag. Dated 10.10.2005 are repeatedly requesting for releasing of withheld annual increment w.e.f. 01.07.2009.

Therefore, the Governing Body is requested to consider this agenda and give appropriate direction to the Dean.

24. Agenda Item No. 24 of XXXXI meeting:

TO CONSIDER AND RATIFY THE ACTION TAKEN REGARDING WITHHELD EARNED LEAVE ENCASHMENT OF Dr.D.ADIROUBANE IN VIEW OF EXCESS PAYMENT MADE ON PROMOTION TO THE POST OF PROFESSOR WHICH WAS CHALLENGED BY DIRECTLY RECRUITED PROFESSORS.

Dr. D. Adiroubane, Professor (Retired) was earlier working as Agricultural Officer and came to PAJANCOA from the Department of Agriculture on deputation and subsequently got absorbed as Asst. Professor on 05.11.1990. Whereas, his past service as Agricultural Officer in the Agricultural Department, Government of Puducherry was counted for promotion to the post of Professor at PAJANCOA & RI by G.O. Ms. No.22/Ag Dt.10.10.2005 and got promoted as Professor under Career Advancement Scheme based on the interview conducted on 28.02.2008. Dr. D. Adiroubane had retired from service on superannuation on 31-08-2012.

The said G.O. Ms. No.22/Ag Dt.10.10.2005 was challenged by the directly recruited Professors in the Hon'ble High Court of Madras and in the judgement, the Hon'ble High Court of Madras has set aside the G.O. Ms. No.22/Ag Dt.10.10.2005. As a first step towards implementing the judgement, the then Collector-cum-Dean, PAJANCOA & RI withheld the annual increment w.e.f. 01.07.2009.

Whereas, nine Professors and two Associate Professors, who were absorbed from the Department of Agriculture, challenged the judgement of the single judge through writ appeals No.1467 &1468/2009 Dt.17.03.2010. The Bench in its order dismissed the appeal and upheld the judgment.

Out of the said nine Professors, only seven Professors including Dr.D.Adiroubane again appealed against the judgement dated 12.09.2011 of the two member Division Bench of Hon'ble High Court of Madras on 19.11.2011 at the Hon'ble Supreme Court of India through a petition for Special Leave to Appeal (civil) No.33338 -33339 of 2011. At present this case is pending before the Hon'ble Supreme court of India.

Moreover, The A.G. Audit in their Inspection Report (I.R.68/2001-2002 Dt.08.11.2001) raised objections regarding the implementation of revised ICAR/UGC Scales of pay in PAJANCOA & RI, vide Part II A (1) of IR 68/2001-2002 for the irregular fixation of pay on promotion as Associate Professor under CAS and grant of Advance Increments to the Professors including Dr. D. Adiroubane of this institution and the same was included in the "Review Report on the functioning of the professional colleges in the union territory of Pondicherry" vide Para 8.9. The Audit Para is still pending.

In addition, the A.G Audit, Puducherry in their Audit Para No.PBS-I /2/IR-150/2009-10 dated 20-10-2010, objected the promotion to the post of Professor vide G.O.Ms.No.22, and pointed out that the promotion was not in consonance with the UGC guidelines for Career Advance Scheme, and directed to effect the recovery of excess payment due to incorrect adoption of Career Advancement Scheme. This Audit Para is also still pending.

In the above background, if the Supreme court issues orders in favour of the Professors, reversion to original posts and the pay recovery does not arise. Otherwise if the court orders are not in their favour, recovery of pay will be in force and the Professors have to be reverted back to Associate Professors. Meanwhile Dr. D. Adiroubane, Professor has retired from service on superannuation on 31.08.2012. Moreover, there is no pension scheme in PAJANCOA & RI, Karaikal to recover the due amount from him. However, Dr. D. Adiroubane is eligible to get his cash equivalent of leave salary (Rs.3,37,525) in lieu of unutilized Earned Leave/HPL at the time of retirement on Superannuation.

The over payment made to Dr.D.Adiroubane in view of his promotion to Associate Professor and Professor was approximately worked out to Rs. 3,47,263/- (Rupees three lakhs forty seven thousand two hundred and sixty three only) which has to be recovered.

At this juncture, it is submitted that as on date there is no pension scheme at PAJANCOA&RI. Therefore, recovery of excess payment is possible only from encashment of leave salary. Hence, with the approval of the Chairman, the E.L encashment for Dr. D. Adiroubane has been withheld for adjusting the same against the overpayment made due to the promotion to the post of Professor, which was challenged and is pending in the Hon'ble Supreme Court of India.

The Governing Body is requested to consider this agenda and ratify the action taken by the Dean for withholding the leave encashment amount so as to adjust the excess payment made to Dr.D.Adiroubane.

25. Agenda Item No. 25 of XXXXI meeting:

TO APPRAISE THE COURT CASE IN W.P.NO.33325 OF 2012 FILED BY DR.D.ADIROUBANE REGARDING RETIRAL BENEFITS (PENSIONARY BENEFITS)

Dr. D. Adiroubane was serving as Agricultural Instructor / Agricultural Officer in the State Department of Agriculture from 19.11.1973 to 04.11.1990. On deputation from the Department of Agriculture, he joined PAJANCOA&RI on 05.11.1990 as Assistant Professor. He retired from PAJANCOA&RI on 31.08.2012 after attaining superannuation. He retired as the Professor of Agricultural Entomology.

As there was no pension scheme at PAJANCOA&RI, he was not given any pensionary benefit.

Dr. D .Adiroubane gave representations regarding his retirement benefits viz. Pension, Gratuity etc. In this regard, a file was submitted by the Dean to the Chief Secretary cum Chairman, PAJANCOA (Karaikal) Society vide File No.6766/PJN/Estt./E1/Pension/2010 dated 30.11.2010. After detailed analysis, the DP & AR, Puducherry advised that Pro-rata pension for the period of service from 19.11.1973 to 04.11.1990 at Agriculture Department may be granted to Dr. D. Adiroubane, Professor (retired) as per the guidelines issued in Appendix-7 of CCS (Pension) Rules 1972. It was also advised that his pensionary benefits for the sevice rendered in PAJANCOA&RI may be considered after the outcome of the court case No.W.P.No.13571 of 2011 filed by PAJANCOA&RI Employees Association (Non-teaching staff). The above decision of the Government was also communicated to Dr. D. Adiroubane, Professor (Retired) vide Lr. No.6766/PJN/Estt/E1/Pension/2010 Dt.04.03.2013.

In the meantime, Dr. D. Adiroubane has approached the High Court of Madras and filed Writ Petition No.33325 dated 13th December 2012 praying for grant of pensionary benefits to him. Now the case is pending at the High Court of Chennai.

The Governing Body is requested to take note of the same and advise the Dean in this regard.

26. Agenda Item No. 26 of XXXXI meeting:

TO CONSIDER AND APPROVE THE PROPOSAL FOR PENSION TO THE STAFF OF PAJANCOA & RI.

Initially, the proposal for introduction/implementation of pension scheme to the employees of PAJANCOA & RI, Karaikal was placed in the 31st Governing Body Meeting held on 20-09-2002 and the Dean was directed to put up the proposal in the subsequent Governing Body with detailed particulars of staff and financial implication involved. Accordingly a detailed proposal for the implementation of Pension Scheme was again placed in the 32nd Governing Body held on 04-04-2003. The Governing Body, after detailed

discussion, directed the Dean to refer the matter to the Finance Department, Government of Puducherry. Again the matter was placed for consideration of the 37th Governing Body held on 16-04-2007, wherein the Dean was directed to prepare a Report on the implementation of Pension Scheme with financial implication.

As directed by the Governing Body, the Dean prepared a detailed report on Pension Scheme with financial implication. The same was referred to Finance Department, Puducherry, which in turn has not agreed for the introduction of Pension Scheme (Defined Pension Scheme under CCS (Pension) Rules 1972, which is existence prior to 01-01-2004 to the employees of autonomous bodies like PAJANCOA & R.I). The PAJANCOA&RI has belatedly initiated the proposal for implementation of Pension Scheme and also sought for Rs.one crore for year 2007-2008 from the Government as initial corpus fund and there after Rs.50.00 lakhs every year for creating corpus fund to start its own Pension Scheme and the same has been turned down by the Government in 2008 itself and referred the file with remarks that the introduction of Pension Scheme on Government of India pattern to the employees of Autonomous Bodies/ Societies should not be agreed to as a Rule and any exemption in this regard has to be referred to the Ministry of Finance, Government of India.

In the meantime the Finance Department, Puducherry issued a Circular No. FD/4407/F3/2009 dated 20-10-2009, which states that the New Pension Scheme for new entrants in service with effect from 01-01-2004 would be applicable to only those institutions where the Pension Scheme under the CCS (Pension) Rules 1972 is already in existence up to 31-12-2003. Hence, as per existing norms of the Government, the employees of the PAJANCOA & R.I, Karaikal could not be brought under the Defined Benefit Pension Scheme which were in existence up to 31-12-2003 or New Pension Scheme with effect from 01-01-2004 which leads to a piquant situation of leaving the employees who have put in 20 years of service or more in quandary. However, PAJANCOA & R.I, Karaikal is an autonomous institution under the Societies

Registration act 1860 which is fully funded by the Government of Puducherry. Even though the institution has been started long back on 02-10-1987, the matter was not seriously taken up by the then Deans of the Institute nor by the Government as well till September 2002. As such, the matter of consideration of Pension to the employees was not at all taken up with the Govt. at the appropriate time and hence appropriate decision was not arrived at. There are four types of employees at PAJANCOA&RI who are repeatedly representing for pension. Their category and present status of their request are furnished below.

2.		PAJANCOA&RI has not given any specific commitment as given to the four directly appointed Professors from TNAU. However, the Agricultural Officers turned Professors are requesting for pension as they come from pensionable establishment. Dr.D.Adiroubane,

		He has now filed a W.P.No.33375/2012 in the High Court of Madras praying for pensioner benefits and at present this case is pending before the Hon'ble High Court of Madras.
3.	The teaching staff and non- teaching staff who were appointed in PAJANCOA&RI before 31.12.2003 (125 numbers)	The non-teaching staff Association (PAJANCOA&RI employees Association) represented by its Secretary Mr.G.Marudhamuthu had filed a writ petition No.13571 of 2011 at the High Court of Chennai, praying for pensionary benefits. The case is pending at High Court of Madras.
4.	The teaching and non- teaching staff who were appointed after 01.01.2004 (102 employees)	PAJANCOA & RI, Karaikal has now proposed to start CPF Scheme in respect of these employees. In this regard, a detailed note was submitted to the Chief Secretary cum Chairman. The Chief Secretary to Govt. –cum- Chairman, PAJANCOA (Karaikal) Society, has directed the Dean to place the same in the ensuring Governing Body meeting. Accordingly, this agenda is placed in the 41 st meeting of the Governing Body.

In respect of the 3rd category of staff, the PAJANCOA & RI Employees Association represented by its Secretary Thiru. G. Maruthamuthu, who is working as MTS (Security), has filed a case at Hon'ble High Court of Madras in W.P.13571/2011 for payment of Pension and GPF to the employees of PAJANCOA & RI, Karaikal. At present this case is pending before the Hon'ble High Court of Madras.

The Governing Body is requested to consider this agenda and give appropriate direction to the Dean.

27. AGENDA ITEM NO.27 of XXXXI meeting:

TO CONSIDER AND APPROVE THE PROPOSAL FOR CREATION OF 67 POSTS OF MULTI TASKING STAFF (AGRICULTURAL MAZDOOR) AND TO ABSORB AND REGULARIZE THE FULL/PART TIME CASUAL LABOURERS AGAINST THE SAME.

There are 67 Daily Rated Seasonal Agricultural Labourers/Full Time Casual Labourers who are engaged in the agricultural field work by the Department of Agronomy, Horticulture and Engineering Cell of the PAJANCOA & R.I. Karaikal. Due to their continued engagement in the Agricultural field work and other related work, they have crossed their age limits for direct recruitment in other fields/organizations. Out of the 67 Full Time Casual Labourers, 65 employees have completed more than 10 years of service in PAJANCOA & R.I., as on 31.12.2012 and the remaining two employees have completed 9 years of service.

The matter was already placed before the 38th Meeting of the Governing Body held on 23.02.2010 vide agenda item No.30 and the Governing Body accepted in principle for creation of fifty seven posts of Agricultural Mazdoor in the Pay Band of Rs.5200-20200 (PB-1) with the Grade Pay of Rs.1800/- and absorb the 57 Daily Rated Seasonal Agricultural Labourers/Full Time Casual Labourers, who have put in more than 10 years of service in PAJANCOA & RI., Karaikal as on 28.02.2009. The Service Association frequently demanded that the services of all the Daily Rated Seasonal Agricultural Labourers/Full Time Casual Labourers/Full Time Casual Labourers to be regularized and absorbed against post of Agricultural Mazdoor posts to be created.

While sending file for creation of 57 posts of Agricultural Mazdoors, to the Government, the Chief Secretary to Government –cum-Chairman, PAJANCOA (Karaikal) Society directed the Dean to put up the file by following the guidelines notified by the DP& AR in G.O. Ms. No.22, dated 27.02.2009 in regard to regularization of full time/part time casual labourers and also advised to send a formal proposal for creation of posts on functional requirement at the first instance and also seek approval for publication of draft list of casual labourers working in the Institution as per G.O. Ms. No.22 dated 27.02.2009. Accordingly, the draft list of Full Time Casual Laboures of this Institution was prepared and submitted to the Chief Secretary to Government –cum-Chairman, PAJANCOA (Karaikal).

As per the guidelines issued in G.O. Ms. No. 22, this institution has now proposed to create 67 posts of Multi Tasking Staff (Agricultural Mazdoor) which is equivalent to the Multi Tasking Staff (House Keeping) posts in the Government Departments in order to perform duties in the Agricultural Fields. Out of the 67 MTS (Agricultural Mazdoor) posts, 65 posts will be filled by the existing 65 Daily Rated Seasonal Agricultural Labourers/Full Time Casual Labourers those who have completed 10 years or more service by absorption and the remaining two posts will be filled on completion of ten years service by the existing two full time casual labourers those who have not completed ten years service, by absorption. The resultant posts of the Daily Rated Seasonal Agricultural Labourers/Full Time Casual abolished.

The Governing Body may consider and approve the creation of 67 posts of Multi Tasking Staff (Agricultural Mazdoor) and absorb and regularize the existing Part time / Full Time Casual Labourers as one time measure. The resultant Part time / Full Time Casual Labourer's vacancies will not be filled up in future.

28. Agenda Item No. 28 of XXXXI meeting:

TO CONSIDER AND APPROVE THE CONTRIBUTORY PROVIDENT FUND SCHEME (CPF SCHEME) FOR THE EMPLOYEES OF PAJANCOA&RI WHO JOINED ON OR AFTER 01.01.2004.

At present the GPF scheme is in operation for the employees of PAJANCOA&RI who joined on or before 31.12.2003. The employees who have joined on or after 01.01.2004 are willing to subscribe to the Contributory Provident Fund Scheme (CPF scheme). Hence, it is proposed to implement CPF scheme to the employees of PAJANCOA&RI who joined on or after 01.01.2004, as implemented in the Puducherry Engineering College (PEC) and Perunthalaivar Kamarajar Institute of Engineering and Technology (PKIET), Karaikal. As on date, there are 21 (twenty one) teaching staff and 20 (Twenty) non-teaching of staff who are to be considered under CPF scheme. A proposal was submitted to the Chief Secretary – cum – Chairman, PAJANCOA (Karaikal) society in file for implementation of CPF scheme for those employees who have joined on or after 01.01.2004. The Chief Secretary – cum – Chairman directed the Dean to place the proposal for implementation of the CPF scheme in PAJANCOA&RI in the ensuing Governing Body meeting for taking a decision. Accordingly the said proposal is placed herewith for the consideration of the Governing Body.

The Governing Body is requested to consider and approve the proposal for implementation of CPF scheme for the employees of PAJANCOA&RI who joined on or after 01.01.2004.

29. AGENDA ITEM NO. 29 of XXXXI MEETING:

TO CONSIDER AND APPROVE THE PROPOSAL FOR TAKING ACTION AGAINST DR. R. HARIHARAN, ASSOCIATE PROFESSOR AND DR. N. MAHESH, ASSISTANT PROFESSOR FOR TERMINATION FROM SERVICE.

Dr. R. Hariharan, Associate Professor (Soil Science & Agricultural Chemistry) initially joined this Institution on 15.11.1989 as Assistant Professor and got promoted as Associate Professor with effect from 05.11.1999. He was granted E.O.L for 3 years from 02.12.2002 to 01.12.2005 to go to France. He further requested for extension of EOL for one year 11 months from 02.12.2005. His request for extension of leave was refused by the administration and he was instructed to report for duty. On 15.10.2006, he requested this administration that he may be considered to go on Voluntary Retirement. But his request was also not considered since this Institution has not adopted any Pension Scheme and he had completed only 13 and half years of service. It is mandatory that 20 years service is required to a Government servant to go on voluntary retirement. From 02.12.2005, he failed to report for duty and he is on overstayal of leave. In this regard, many communications were sent to Dr. R. Hariharan, Associate Professor and he

again requested the administration on 27.05.2008 that his overstayal of leave period may be ratified and requested to consider his application for voluntary retirement. From that date, there is no communication received from him.

Dr. N. Mahesh, Assistant Professor (Agricultural Economics) initially joined this Institution on 17.01.2003 as Assistant Professor. He had applied Commuted Leave from 03.11.2007 to 18.11.2007 without Medical Certificate and on expiry of the leave he had applied earned leave from, 19.11.2007 to 18.12.2007 and 19.12.2007 to 16.02.2008 on medical grounds. Whereas his leave was refused by the Administration and he was instructed to report for duty immediately. But he had not reported to duty and no further leave application/communication was received after 16.02.2008. In this regard, this office had sent a Memorandum on 18.02.2008 and a Telegram on 25.02.2008 recalling him for duty and the two communications were returned unserved. As per the orders of Chief Secretary to Govt.-cum-Chairman, this Institution has initiated disciplinary proceedings against him and show cause notice were sent to his residential address at Karaikal and Dindigul on 21.052008 and 12.06.2008. All the above letters were returned unserved with postal endorsement 'left'. He remains absent unauthorizedly and the whereabouts of Dr. N. Mahesh, Assistant Professor is not known. It is therefore not reasonably practicable to hold an enquiry under Rule 14 of the CCS (CCA) Rules, 1965 against the two said individuals. Where it is not reasonably practicable to hold inquiry, a person may be dismissed by dispensing inquiry, after recording that it is not reasonably practicable to hold such inquiry as per Rule 19 (ii) of the CCS (CCA) Rules 1965.

Therefore, the Governing Body may consider and approve the following:

- (1) The request for Voluntary Retirement given by Dr. R. Hariharan, Associate Professor need not be considered. Permission may be granted to terminate him from service since he had settled in France and it is not possible to hold an inquiry against him.
- (2) To dispense the inquiry process against Dr. N. Mahesh, Assistant Professor and to terminate him from service, since he had absconded from duty and from his last known residential address and this office do not know his present address and it is not possible to hold an inquiry against him.

(3) To publish the dismissal orders of Dr. R.Hariharan and Dr.N.Mahesh in the local news paper and to display the dismissal order in the College Website.

30. Agenda Item No. 30 of XXXXI meeting:

TO APPRAISE THE GOVERNING BODY OF THE ACTION TAKEN ON GENERATING INCOME AT PAJANCOA&RI.

In order to generate internal revenue, the following are the action taken/being taken by the PAJANCOA & RI.

- 1. Collection of hire charges for sparing of vehicles to other Departments, Scheme Activities etc.
- 2. 10% increase in tuition fees every year.
- Collection of non-refundable hostel utility charges @ Rs.5000/-(Rupees five thousand only) per student from the ensuing academic year starting July-August-2013.
- 4. Collection of rent from Indian Bank and Xerox Centre for the space provided to them.
- 5. Funding from other agencies (external funding) for research projects.
- Admission of candidates (not exceeding 10% of sanctioned strength of 80) under NRI quota.
- 7. Through Consultancy Services
- 8. Increasing of revenue from PAJANCOA&RI' Farms.

The Governing Body is requested to take note of the agenda for favour of kind information.

31.Agenda Item No.31 of XXXXI meeting:

TO APPRAISE THE GOVERNING BODY OF EXTERNALLY FUNDED PROJECTS BEING OPERATED IN PAJANCOA&RI.

The list of externally funded Projects / Research Projects being operated at PAJANCOA &RI is furnished in Annexure-II. The Governing Body is requested to take note of the same for favour of kind information.

32. Agenda Item No.32 of XXXXI meeting:

TO RATIFY THE TRANSFER OF VARIOUS ACCOUNTS FROM STATE BANK OF INDIA (ADB) TO INDIAN BANK, KARAIKAL.

A new branch of Indian Bank was opened on 22.07.2011 in the PAJANCOA&RI – PKIET campus to serve both the colleges and the adjoining general public, with the approval of the Chief Secretary and Chairperson. An MOU was also signed by PAJANCOA&RI and Indian Bank in this regard.

The Indian Bank has been approaching the PAJANCOA&RI to have all transactions at Indian Bank as its new branch at PAJANCOA&RI campus was started anticipating the transactions of both PAJANCOA&RI and PKIET colleges.

There were lot of inconveniences in transacting with State Bank of India (ADB). That is, the Cashier has to commute about 10 kms from PAJANCOA&RI to SBI(ADB) Karaikal. A separate vehicle was also needed often for transactions and reconciliations. The Cashier can save lot of time, energy etc., if the accounts are transferred from SBI(ADB) to Indian Bank.

Therefore, with the approval of the Chief Secretary and Chairperson, all the accounts were transferred from State Bank India(ADB) to Indian Bank at PAJANCOA&RI campus.

However, salary account of all the individual staff members are retained by the individuals at SBI(ADB) as per their wish. The Employees Associations of PAJANCOA&RI requested the Dean to deposit their salary to their salary account at SBI (ADB) for two reasons viz., (i) most of the staff members are residing at Karaikal town and (ii) the employees feel there are lot of ATM outlets for SBI all over India so that transactions are easy wherever they go.

The Governing Body is requested to consider and ratify the transfer of all other accounts of PAJANCOA&RI except salary account from State Bank of India (ADB) to Indian Bank, PAJANCOA&RI campus.

33. Agenda Item No. 33 of XXXXI meeting: TO CONSIDER AND APPROVE THE TRANSFER OF 20 ACRES OF LAND TO PKIET FROM PAJANCOA&RI.

Perunthalaivar Kamaraj Institute of Engineering and Technology (PKIET) was started in the academic year 2007-2008 at PAJANCOA&RI campus. The Central Farm Complex of 10 acres along with built up area of 2851 sq.m. was leased out to the PKIET and the lease agreement was executed between the Dept.of Agriculture, Govt.of Puducherry and the PKIET.

The Directorate of Higher & Technical Education, Puducherry had requested the Director of Agriculture for transfer of an additional 25 acres from PAJANCOA&RI, for expanding the PKIET campus, <u>vide</u> letter No.4422/DHTE/Estt./PKIET/C2/2011/337, dt. 07.09.2011. The Director of Agriculture had sought some details regarding cropped area, area under building, cropping programme etc. and the views of the Dean regarding the request for transfer of 25 acres of land <u>vide</u> Letter No.5771/Agri-Dte./2011/C2, dt.16.09.2011.

The Dean furnished the details besides his views on the proposed transfer of 25 acres to the PKIET <u>vide</u> letter No.Dean/PJN/Transfer of land/2011-12, dt.08.11.2011.

Subsequently, the Chief Secretary to the Govt.of Puducherry along with the District Collector of Karaikal visited the PKIET on 21st January 2012. The Dean, PAJANCOA&RI and the Principal, PKIET were present, during the visit. There was a discussion regarding transfer of lands to PKIET. On hearing the views of the Dean, PAJANCO&RI and the Principal, PKIET, the Chief Secretary to the Government visited the spot (land/site) that was proposed for transfer. At the end of the discussion, the Chief Secretary directed the Dean, PAJANCOA&RI to arrange to transfer 25 acres of land to PKIET. Further, the Chief Secretary also directed that the 10 acres of land (Central Farm Complex) along with the built up area of 2851 sq.m. already allotted to the PKIET may be transferred back to the PAJANCOA&RI. Based on the spot visit and the direction given by the Chief Secretary, a factual report was submitted by the Dean, PAJANCOA&RI vide Note No.Dean/PAJANCOA&RI/CS visit/2011-12, dt. 30.01.2012 to the Chief Secretary through the Secretary to the Govternment (Agriculture). The Secretary to the Govt.(Agriculture) directed the Dean to place this subject in the Governing Body of PAJANCOA&RI for taking a final decision in this regard.

Therefore, the matter was placed in the 40th Governing Body of PAJANCOA&RI held on 16.02.2012. The following is the decision of the Governing Body.

(i) The GB decided to allot only 20 acres of land in the Western farm area in the end of the farm to PKIET. The present entry point in the Central Farm Complex facing east of Nedungadu main road will be restored to PAJANCOA & RI. The PKIET will have separate main gate in the Pathakudy main road in the 20 acres of land to be allotted to the PKIET.

(ii) The Central Farm Complex with 10 acres of land along with buildings which were transferred to PKIET in 2008 and which are now in the possession of the PKIET will be handed over back to PAJANCOA & RI, after the construction of new academic building by the PKIET in the 20 acres to be allotted.

(iii) A common area of five acres will be allotted to create common facilities for PAJANCOA & RI and PKIET

(iv) The GB recommended to form a common management committee for creating the common facilities in the five acres of land for both the colleges.

The decision of the Governing Body was communicated to the Principal, PKIET with a copy to the Director of Agriculture, Govt.of Puducherry <u>vide</u> letter No.Dean/PJN/Engg.Cell/G.B./Land transfer/2011-12, dt. 26.03.2012.

Subsequently, the Director of Agriculture sought some clarifications from the Dean, PAJANCOA&RI vide his letter No.5771/Agri.-Dte./2011/C2, dated 12.04.2012. Those details to be furnished by the Principal, PKIET as listed below were collected by Dean, PAJANCOA&RI.

i. Formal request for minimum area requirement certificate.

- ii. Certificate for non-availability of any other suitable poromboke land.
- iii. Certificate for non-structure / buildings of sentimental or religious or communal importance on the lands proposed for the transfer of land.

Besides above details, the technically scrutinized FMB sketch and subdivision statement in respect of lands to be transferred at Sorakudy village (R.S.No.127, 128 and 131 to 137 of Karaikal District) furnished by Sub-Collector(Revenue) of Karaikal District were sent to the Director of Agriculture for further action vide No.PAJ/EC/Land Transfer/2012-13, dated 28.09.2012.

Subsequently, the Director of Agriculture sought some other additional details / particulars viz., exact location of the land to be transferred with village name, total land extent, survey numbers and boundaries etc. along with back files, vide Letter No.5771/Agri.-Dte./2011/C2, dated 19.10.2012. The Dean furnished the above information, after collecting the same from the Sub-Collector(Revenue), to the Director of Agriculture <u>vide</u> Lr.No. Dean /PJN/ Engg.Cell/G.B./Land Transfer/2011-12/566, dt. 27.11.2012 and 07.01.2013 with a request to arrange to issue a G.O. for transfer of 20 acres of land from PAJANCOA&RI to the PKIET.

The Director of Agriculture informed the Dean that the whole proposal of transfer of land with all details were re-submitted to the Chief Secretariat (Agriculture) and requested the Dean to follow–up for getting necessary G.O. from the Government. Therefore the Dean is pursuing this matter with the Under – Secretary to the Govt.(Agriculture) to get a G.O. for the transfer of land.

At this juncture, now the Principal, PKIET has requested to moot out a fresh proposal to transfer of 15 acres of land adjacent to the present location of the PKIET (i.e., the Central Farm Complex of PAJANCOA&RI under the possession of the PKIET), <u>vide</u> his letter No.PKIET/2013/Land Transfer/2858, dt.27.02.2013, stating that the above decision was taken in the Governing Body meeting of PKIET held on 29.01.2013.

The request of the PKIET in the eleventh hour, after the whole process of transfer of land is in the final stage of issue of a G.O. by the Government based on the decision of the Chief Secretary during the spot visit on 21.01.2012 and subsequently by the decision of the Governing Body of the PAJANCOA&RI held on 16.02.2012, seems to be only a delaying tactics.

Hence, the Governing Body is requested to consider this proposal and give further direction in this regard.

34. Agenda Item No. 34 of XXXXI meeting:

TO CONSIDER AND APPROVE SPECIAL GRANT FOR SILVER JUBILEE CELEBRATION OF PAJANCOA&RI

The PAJANCOA was stated on 2nd October 1987 at Karaikal and later on it was upgraded as a Research Institute in 1996 and renamed as PAJANCOA&RI. It has already entered its silver jubilee year since October 2011. To give a face-lift for a new lease of life to PAJANCOA&RI as well as to commemorate the Silver Jubilee year, a proposal was submitted in file (No.Dean/PJN/Silver Jubilee/Grant/2012-13, dt.03.09.2012) to the Government of Puducherry for favour of the approval. A sum of Rs.2.5 crores was sought as a special grant for the following item:

TO APPRAISE THE GOVERNING BODY OF THE VISIT OF STANDING COMMITTEE TO PAJANCOA&RI FROM TAMIL NADU AGRICULTURAL UNIVERSITY, COIMBATORE.

The PAJANCOA&RI is affiliated to the Tamil Nadu Agricultural University (TNAU), Coimbatore since its inception on 2nd October 1987. It is customary that the Standing Committee comprising of University Officers viz., Dean, Directors, Registrar, etc. used to inspect all the affiliated Agricultural Colleges of the Tamil Nadu Agricultural University to monitor the academic performance of colleges as well as to assess the infrastructural facilities required for each of the affiliated institution to ensure academic standard of colleges. In the same analogy, the Standing Committee of TNAU visited PAJANCOA&RI on 19th June 2013.

The Standing Committee of the TNAU that visited PAJANCOA&RI on 19th June 2013 consisted of the following officials:

Due to some urgent unexpected official work, the Registrar could not come to PAJANCOA&RI on 19.06.2013. Hence, the Committee under the Chairmanship of Dean(Agriculture) with the other four members inspected PAJANCOA&RI on 19th June 2013. The Standing Committee visited the Lecture Halls, Education Cell, Examination Halls, Library and College Farms. The Standing Committee members also interacted with Under-graduate and Post-graduate students separately. The committee members also had free discussion with all Heads of Departments and some staff members.

The Standing Committee is of the view that the academic standards and infrastructural facilities of PAJANCOA&RI is better than the other affiliated colleges of TNAU. However, the committee requested the Dean to create more facilities to uplift PAJANCOA&RI on par with the Agricultural College and Research Institute at Coimbatore in all respects, especially with reference to hostel facilities, library facilities and sports facilities.

This agenda is placed before the Governing Body for favour of kind information.

36. Agenda Item No. 36 of XXXXI meeting:

TO CONSIDER AND RATIFY THE CIVIL WORKS UNDERTAKEN BY THE ENGINEERING CELL OF PAJANCOA&RI

The Engineering Cell of PAJANCOA&RI, Karaikal has executed the following mainly civil works, since January 2012. These civil works were under repair and maintenance in nature. The civil works within the estimate of Rs.one lakh were carried out within the financial power of Dean (as approved by the XIX meeting of the Governing Body held on 11.02.1998) and the civil works with an estimate of more than one lakh were carried out after obtaining the approval of the Chief Secretary – cum – Chairperson, PAJANCOA (Karaikal) Society. For want of sufficient funds only important and essential work (repair and maintenance) were carried out.

The Estimate were prepared by the Executive Engineer of Engineering Cell, who is on deputation from Public Works Department. The Executive Engineer is shown in the establishment of PAJANCOA&RI and his services are spared to Thirunallar Temple Project.

The Governing Body is requested to consider the civil works done as listed (in Annexure-III) and ratify the action taken by the Dean.

37. Agenda Item No. 37 of XXXXI meeting:

TO CONSIDER AND APPROVE THE AUDITED ACCOUNTS OF PAJANCOA&RI AND TO RATIFY THE APPOINTMENT OF THE AUDITORS.

With the approval of the Chief Secretary to the Government – cum – Chairman, PAJANCOA (Karaikal) Society, M/S. B.V.Balaji & Company, Kumbakonam were appointed to audit the accounts of PAJANCOA&RI for the years 2010-2011, 2011-2012 and 2012-2013 . So, the Statutory Audit for the year 2011-2012 (01.04.2011 to 31.03.2012) was completed by M/s. B.V.Balaji & Company, Kumbakonam (Annexure-IV). The A.G. Audit for the year 2010-2011 (02.04.2010 to 31.03.2011) was also completed. A sum of Rs. 9 crores and 99 lakhs was released as Grant-in-Aid for the year 2011-2012 as against the Budget Estimate of Rs.10 crores.

The Governing Body is requested to note the same for favour of information. The Governing Body is also requested to ratify the appointment of M/s B.V.Balaji & Co., Kumbakonam as Auditors for auditing the accounts of PAJANCOA&RI in 2010-2011, 2011-2012 and 2012-2013.

38. Agenda Item No. 38 of XXXXI meeting:

TO CONSIDER AND APPROVE SPECIAL GRANT FOR REPAIR AND MAINTENANCE OF BOYS' AND GIRLS' HOSTELS OF PAJANCOA&RI.

The Boys' and Girls' Hostels of PAJANCOA&RI were constructed 13 years back in 1999. The details of plinth area and number of rooms in the hostels are furnished below:

The boys' hostel was constructed at an estimated cost of Rs.2,43,03,587/- and that of girls' hostel at an estimated cost of Rs.2,38,45,565/-. For the past 13 years, no major repair work was undertaken. During these years, colour washing and paintings were also not given. Hence both the hostels are in very shabby condition which needs immediate repair and maintenance work for the normal stay of the students. Moreover, the bathroom doors, toilet doors kitchen floors are in bad shape which needs total renovation.

The Engineering cell at PAJANCOA&RI headed by an Executive Engineer who is on deputation from Public Works Department, Govt.of Puducherry has prepared the estimate for the patch work, colour washing and painting which works out to Rs. 2.60 crores for both the hostels. The work needs to be taken up on priority basis in phased manner considering the budget constraint.

Hence, the Governing Body is requested to consider this proposal and approve for allotting a special grant of Rs.1.3 crores in the first phase during the current year and another Rs.1.3 crores in the second phase during next year.

To consider and ratify the amendment of Recruitment Rules (RR) for the direct recruitment of the Assistant Professors at PAJNCOA and RI, Karaikal based on the new UGC Guidelines, 2010

In the Governing Body meeting, a question was raised by the MD, PASIC that whether three years degree of B.Sc. (Home Science) is considered for recruitment in State Agricultural Universities (SAUs). The Dean said that only four years B.Sc. (Home Science) is considered in SAUs. However the GB directed the Dean to verify the same. It was verified by the Dean and confirmed that in all SAUs a uniform decision was taken to offer four years degree programme of B.Sc. (Home Science). The ICAR decided not to fund three years B.Sc. (Home Science) programme in SAUs. The ICAR made it mandatory that the B.Sc. (Home Science) programme should be four years programme and only those candidates who have completed four years B.Sc. (Home Science) programme will be considered for M.Sc. (Home Science)/M.Sc. (Ag.) programmes and for direct recruitment of Assistant Professors in SAUs. It was also suggested by the GB that in serial No. 9 (of agenda No.4 of XXXX meeting, Page No. 14) of recruitment rules to retain "Not applicable" and delete the sentence "since it is entry cadre" and the corrections were made in the recruitment rules as suggested. The GB also suggested to notify the recruitment rules in the Gazette of Government of Puducherry.
