From the current academic year, PAJANCOA&RI is affiliated to Pondicherry University. Hence, the Chairman presented the proposed fee structure falling in line with other professional colleges in the U.T. of Puducherry affiliated to Pondicherry University.

Omar Hattab as Dean-in-charge, requires to be vacated urgently. A special Advocate will be engaged to vacate the stay since students are badly suffering and absence of Dean is causing severe inconvenience to the functioning of the Institute
- (2) The Secretary (Law) informed that there is a court case regarding affiliation. The Dean/ Technical and Personal Officer to Dean were directed to monitor the matter and ensure that the interest of the Society and the Government is duly protected by filling timely reply and engaging competent Advocate.
