NOTIFICATION

In exercise of the powers conferred under rule 11(2) (n) of the Pandit Jawaharlal Nehru College of Agriculture and Research Institute (Karaikal) Society Rules and Regulations and all other enabling powers conferred on the Governing Body of the Pandit Jawaharlal Nehru College of Agriculture and Research Institute, Karaikal, in this behalf, the Governing Body of the Pandit Jawaharlal Nehru College of Agriculture and Research Institute, Karaikal with the approval of the Lieutenant-Governor, Puducherry, hereby makes the following rules regulating the method of recruitment to the Group 'C' post of " **Multi Tasking Staff (General)** " in the Pandit Jawaharlal Nehru College of Agriculture and Research Institute, Karaikal under the control of the Department of Agriculture & Farmers Welfare, Government of Puducherry, namely:—

1. Short title and commencement.—

(i) These rules may be called the "*Pandit Jawaharlal Nehru College of Agriculture and Research Institute, Karaikal, Group 'C' post "**Multi Tasking Staff (General)**" Recruitment Rules, 2026*".

(ii) They shall come into force on and from the date of their publication in the Official Gazette.

2. *Number of post, its classification and Pay Level in the Pay Matrix.* - The number of the said post, its classification and Level of pay in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed hereto.

3. *Method of recruitment, age-limit and other qualifications.* -

The method of recruitment to the said post, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (12) of the said Schedule.

4. *Dis-qualification.* - No person, -

(a) Who has entered in to or contracted a marriage with a person having a spouse living; or

(b) who, having as spouse living, has entered in to or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Governing Body of Pandit Jawaharlal Nehru College of Agriculture and Research Institute, Karaikal, with the approval of the Hon'ble Lieutenant-Governor, Puducherry, may, if satisfied that such marriage is permissible under the Personal Law applicable to such person and the other party to the marriage, and there are other grounds for so doing, exempt any person from the operation of this rule.

6. *Power to relax.*- Where, the Governing Body of Pandit Jawaharlal Nehru College of Agriculture and Research Institute, Karaikal, is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and with the approval of the Hon'ble Lieutenant- Governor, Puducherry, relax any of the provisions of these rules with respect to any class or category of persons.
7. *Savings.*- Nothing in these rules shall affect the reservations, relaxation in upper age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.

5.	Whether selection post or Non-Selection Post	Not applicable
6.	Age limit for Direct recruits	Between 18 and 30 years. of age. Note: The crucial date for determining the age limit shall be as advertised by the Competent Authority
7.	Educational and other qualifications required for direct recruits.	(i) A pass in SSLC or its equivalent from a recognized Board or University.
8.	Whether age and educational qualifications prescribed for direct recruits will apply in the case of promotees.	Not applicable.
9.	Period of probation, if any	Two years for direct recruits. Note: Direct recruits would be required to successfully complete a mandatory induction training of at least two weeks duration, as prescribed by the competent authority, for completion of probation.
