MASTER PLAN - REVISED

Pandit Jawaharlal Nehru College of Agriculture, Karaikal started functioning from 28.9.1987 with the joining of Dean. The college was inaugurated by the Hon'ble Chief Minist Shri.M.O.H.Farook under Presidentship of Hon'ble Minister for Agriculture Shri.V.Govindarajan in the presence of Dr.V.Rajagopal Vice-Chancellor, Tamil Nadu Agricultural University, Coimbatore.

The college was brought under the management of an autonomous society since 1.12.1987. The society was named as "Pandit Jawaharlal Nebru College of Agriculture (Karaikal) Society" with the Chief Secretary as the Chairman for the Board of Governor

Initially the Office of the Dean of the Agricultural College was located in the premises of the office of the Additional Director of Agriculture, Karaikal. The college was then housed at the Auditorium of the Arignar Anna Govt.Arts College. At presented buildings; besides utilising the laboratories of the Arignar Anna Govt.Arts College, Karaikal. The Instructional farm was organised at the State Seed Farm, Madur. The staff members are located at three private buildings in addition to Arignar Anna Govt. Arts college, Karaikal, since the strength has been increased to total of 30 teaching staff and 24 supporting staff. The staff strength would be further increased in due course.

With third batch of students, the number of students are in total 136 in which 37 are women. Three hostels, Two for me and another for women are run by the college. 94 men students and 34 women students were the inmates of the hostel.

An area of 96.56 ha. have been chosen for establishing the Agricultural College at Sorakudy and Suprayapuram villages. The site had been recommended by the Accreditation Committee appointed by the Indian Council of Agricultural Research, New Delhi and the Affiliation Team of Tamil Nadu Agricultural University, Coimbatore. Initially a special land acquisition cell was appointed by the Govt.of Pondicherry and further process were continued by the Deputy Collector(Revenue), Karaikal. All the processes were comple and if the amount was given to the land owners during first week of May, 1990 and the land acquisition would be over by Middle of May. It has been estimated that the cost of land would be Rs.68.68 lakhs The Govt.of Pondicherry has already released 6.71 lakhs and order have been issued for the release of 27.00 lakhs. The balance of 34.97 lakhs also to be released by the Government so as to enable the completion of land acquisition.

Since the lands are expected to be handed over shortly and various infrastructure facilities to be developed at Sorakudy, a master plan has been prepared. Taking into consideration the requirements of different disciplines of Agriculture, the students' requirements as a residential Professional College, and the requirements of staff, the various facilities are proposed to be developed. The proposed facilities would also meet the requirements of starting Master's degree programme of studies in Agriculture and the Instituti would also undertake the research needs of the problems of farmers

The Master plan has been prepared at an approximate estimated cost of Rs.887.4 lakhs and the details are

It is also proposed to build the temporary structures at Sorakudy for Dean's office, staff room, for conducting the classes as well as Hostels for men immediately after taking over the lands. These temporary structures would be utilised as Store rooms, sheds, residential buildings for class IV, etc., in future.

Ambala Cantt., at a cost of Rs.13,750/-(Rupees thirteen thousand seven hundred and fifty only) excluding taxes, duties and other incidentals was accorded by the Committee. The Committee permitted the Dean, PAJANCOA, Karaikal to incur the above expenditure.

AGenda Item NO.7:To consider the purchase of Horizontal Laminar Flow Chamber.

Approval for the purchase of Horizontal Laminar Chamber at a cost of Rs.37,960/-(Rupees thirty seven thousand nine hundred andd sixty only) excluding duties, taxes and other incidentals from M/s Klenzaids Contamination Control Pvt.Ltd., Bombay was accorded by the Committee. The Dean, PAJANCOA, Karaikal is permitted to incur the said expenditure.

TO CONSIDER THE APPOINTMENT OF AN ARCHITECT FOR CONSTRUCTION OF THE BUILDING FOR PAJANCOA, KARAIKAL.

The acquisition of the land is nearing completion and therefore the construction of the college building will be taken up shortly. Since the college will exist for hundreds of years it is essential to design the buildings as well as to locate the building at appropriate places in the campuses to be developed in the years to come. Therefore it is felt that the services of reputed architect may be requisitioned for carrying out this important item of work. The architect will provide architectural plans, and the models of the college. The Executive Engineer, Public Work Department, and the Head of Department, of Civil Engineering, Pondicherry Engineering College were consulted in this regard. It is inferred that a reputed architect available with the school of Architecture and Town Planning, Anna University Madras may be utilised for this purpose. The Registrar, Anna University, has nominated Prof.A.N. Sengupta, Director and Professorin-charge, School of Architecture and Town Planning, Anna University, Madras.

Permission for utilising the services of Prof.A.N.Sengupta, has been obtained from the Government of Pondicherry, vide No.I, 32011/3/90/Ag./A3, dated 11th September,1990. The above architect will enter into an agreement with the Dean for undertaking the work. As per the terms and conditions, proposed by the architect, 1½% of the total cost should be paid as his fees besides cost of copies of plans. He has also suggested advance payments in instalments. The terms and conditions suggested by the architect is placed below for the consideration of the Governing Body.

I. General terms and conditions:

- (1) We will prepare a Master Plan (based generally on the programmatic and budgetary Plan prepared by the College and supplied to us on July 27, 1990, with revisions as may be determined prior to the preparation of the Master Plan) for the College to be located on the 96.56 ha land area acquired by the College in Sorakudy and Suprayapuram villages. The Master Plan will include locations of all buildings, sheds, field laboratories, glass houses, water towers, roads, parking areas, footpaths, landscaped areas, playgrounds, farms, orchards, water and waste treatment plants, compound walls, gates and gate-posts etc. as required. Building heights and forms will be shown. Provisions for expansion will be shown as required. Also will be shown the general character of the roads and paths and the landscaped areas between and around the buildings, roads and paths. The works will be provided in terms of site analysis drawings and sketches, and master plan drawings and sketches, an explanatory report and also a Master Plan model at 1:1000 or 1:750 scale as appropriate. A glass cover for the model and a stand for the model will be provided by the college, in situ.
- (2) We will also prepare the architectural designs and architectural working drawings of the buildings, sheds, glass houses, field laboratories and built-in interior elements, and landscaped areas, water towers, compound walls, gates and gate-posts etc. The workswill be provided in terms of floor plans (including locations of all structural, electrical, sanitary and water supply components but excluding engineering details), sections, elevations, details, specifications a perspective drawing and a model for each building etc. at a scale of 1:50 or 1:100 as appropriate.

(3) It is understanding that a unit of P.W.D., attached to the college, will be responsible for all engineering design and details aspects, including structural, electrical sanitary and water supply, preparation of bills of quantities, tender documents, calling tenders, selecting contractors and supervising construction. We understand that the P.W.D. unit will provide us with site levels and/or contours, locations of trees, soil conditions and all pertinent site information prior to the preparation of the Master Plan and also service and utilities information, as appropriate, well before the preparation of the Master Plan drawings and also all preliminary engineering consultation prior to preparation of the architectural designs and detailed engineering informations well before the preparation of the architectural designs and detailed engineering informations well before the preparation of the architectural designs and detailed engineering informations well before the preparation of the architectural working drawings.

II. Time Schedule:

- (1) The time period required for the preparation of the Master Plan will be three months excluding any decision—making time required by the College, (two months for the drawings and one month for the report and the model), after the provision of all background information as stated above and a mobilization advance as stated below.
- (2) The time period required for the preparation of the architectural designs and architectural working drawings of the priority one projects (listed herein, below) will be a total of one year(excluding any decision-making time required by the College) after receiving the mobilization advance ad stated below. However, sufficient drawings and details to enable the P.W.D. unit to proceed with the preparation of the tender documents will be supplied progressively starting from the first three months and within the next three months, so that construction can start at the earliest.

Priority one Projects:

- i) Administrative Building
- ii) Teaching Staff Building:12 Professors, 18 Associate Professors, 48 Assistant Professors.
- iii) Laboratories:
 U.G.laboratories 9 nos. including 16 Agricultural Assistants and 16 Lab Assistants.
 - iv) Lecture Halls: 5 No.(initially @ 50 students each expandable to 100 students each)
 - v) Examination Halls: 3 Nos. @ 100 students each
- vi) Men's Hostel: 100 rooms (50 singles + 50 doubles)
- vii) Women's Hostel: 50 doubles
- viii) Residential Quarters:

 Dean's Bungalow

 6 Professors, 10 Associate Professors, 10 Assistant Professors, 10 Ministerial staff, 5 drivers, office assistants and security guards.
 - ix) College Canteen
 - x) Staff Cooperative Stores.

The time period required for the priority two projects will also be a total of one year, the details being the same as for priority one projects.

Fees:

Our fee for the preparation of the Master Plan will be Rs.One lakh. This will include prints of all drawings, sketches and the explanatory peport in six sets. Extra prints of drawings and extra reports will be payable at Rs.Two per sq.m. and Rs.One per page respectively. Also included will be upto four man-trips between Madras and Karaikal, as necessary, each trip lasting generally one day.

The Master Plan model at the scale of 1:1000 or 1:750, as appropriate, will be supplied at a cost of Rs.10,000.00 (Rupees ten thousand only). This will include a base but not the glass cover and the stand, which by necessity may be built in situ only.

- (2) Our fee for the architectural designs and architectural working drawings will be sum of 1½%(one and a half per cent) of the total cost of the building including civil, electrical, sanitary, water supply and landscaping and built-in interior elements (locations and architectural characteristics of which will be included in our drawings). This will include prints of all drawings in six sets and one set of perspective drawing. Extra prints of drawings will be payable at Rs.Two per sq.m. Also included will be upto six man-trips between Madras and Karaikal, as necessary, during the one year period, each trip lasting generally one day.
- (3) Architectural models at a scale of 1:100 or 1:50, as appropriate, will be supplied at a cost of 0.15%(zero point one five per cent) of the total costs of respective projects. This will include a base but not the glass cover and the stand, which, by necessity, may be built, in situ only.
- (4) Additional trips. if desired by the College, will be reimbursable at actual cost for first class train fare and usual allowances.
- (5) Transportation cost, if any, for the models will be payable at cost only.

III. Schedule of payments of fees:

(1) For the Master Plan, one-third of the fee will be payable as mobilization advance at the time of signing of the Aggreement and one-third will be payable within a fortnight of submission of the plan drawings and sketches and the balance will be payable within a fortnight of submission of the report.

- (2) For the Master Plan model one-half of the fee will be payable as mobilization advance and the balance including transportation costs, if any, upon delivery of the model.
- (3) For architectural drawings and working drawings, one-third of the fee, based on the tentative cost @ Rs.200 per sft, will be payable as mobilization advance, one-third will be payable on submission of drawings sufficient for tendering purposes and the balance will be payable on submission of the working drawings of respective buildings etc.
- (4) For architectural models, one-half of the fee, based on tentative cost @ Rs.200 per sft, will be payable as mobilization advance and the balance including transportation cost, if any, upon delivery of the models of respective buildings etc.
- (5) The Project Coordinator and Architect and Planner of Record will be A.N.Sengupta, Director & Professor In-charge, Centre for Human Settlements, G-2 Quarters, Anna University, Madras-600 025; all Master Plan drawings and report, all architectural drawings including architectural working drawings, "Approved for construction" will be signed by him; all payments will be made out to the same only.

AGENDA ITEM NO.7
TO CONSIDER THE PERIOD OF DEPUTATION OF SOME OF THE STAFF
MEMBERS TO PAJANCOA, KARAIKAL.

Normally, the personnel from the Department or Government deputed to another department or Government normally work for three years on deputation. At times, owing to necessity, the services of some of the staff members who are on deputation for three years are also permitted to serve for one more year with deputation allowance on the basis of the willingness of the individual as well as the requirement of the borrowing institution. As per para 9.2.1 of Appendix-5 of FR & SR part 1, the continuance of the deputee for fourth year may be granted with the approval the borrowing institution.

The deputation period of the members of this institution who have completed/to complete three years may be extended for one more year from the date of expiry of the third year of the deputation in public interest.

TO CONSIDER THE CONSTITUTION OF AN ENGINEERING CELL FOR THE PAJANCOA KARAIKAL.

The land acquisition and preparation of architectural plans are in progress. Therefore constitution of an Engineering Division to take up the construction work is necessary. The Engineering Cell will undertake preparation of cost estimate, supervision of construction work, check measurement and other items of work related to the construction of the various building on the basis of structural plans prepared and furnished by the Pondicherry Engineering College. The Engineering Division will include the following position:

1. Executive Engineer - 1 6. Tracer - 1 2. Assistant Engineer - 2 7. Superintendent - 1 3. Junior Engineer - 3 8. UDC - 2 4. Head Draftsman - 1 9. Class IV servants-1 5. Drafts Man

The Engineering Cell will be constituted in a phased manner based on the demand for manpower from time to time.

TO CONSIDER THE DEPUTATION ALLOWANCE OF THE DEPUTEES FROM TAMIL NADU AGRICULTURAL UNIVERSITY TO PAJANCOA, KARAIKAL.

as per the terms and conditions for deputation of employees of Tamil Nadu Agricultural University, Coimbatore to any foreign employer, the deputee is eligible to draw 20% of the basic pay as deputation allowance (duty pay) from the foreign employer. No ceiling has been fixed for their deputation allowance by the Tamil Nadu Agrl. University. However, the Government of Pondicherry has fixed a ceiling of Rs.500/- as the maximum for the deputation allowance based on the decision of the Government of India. In the Government order G.O.Rt.No.681/Ag. dated 28.6.90 the rate of deputation allowance has been fixed as 10% of basic pay. This is contra to the terms proposed by the lending institution. Hence it is requested that the rate of deputation allowance may be fixed at 20% of basic pay as prescribed by the lending institution with a ceiling of Rs.500/- since the Government of Pondicherry has to abide by the decision of the Government of India with regard to the ceiling of deputation allowance. This modification is required to satisfy the conditions prescribed by the donor institution and the borrower institution.

TO CONSIDER THE PROJECT ALLOWANCE TO THE STAFF OF PAJANCOA, KARAIKAL.

When Agricultural College are established in new locations, initially, the lecture halls, laboratories and hostels are accommodated in private buildings hired on rent in different parts of the town nearer to the sits chosen for the purpose. This involves extra work in establishing the laboratories in unsuitable buildings with specidal equipments and machinerois essentially required for imparting agricultural courses. Moreover, there are no trained supporting staff to assist the teaching staff to collect plants, insects, disease and pest infested plant sp.cimens and also maintaining different agriculture oriented laboratories. Hence staff working in the new campuses have to take extra effort to make their teaching effective. On acquisition of land, the topography of the site has to be studded and it should be classified into, dry, garden, wet and pasture lands. Unless this classification is made and lands levelled raising of different crop and forage plants will be difficult. Realising these dificulties, the Tamil Nadu Agricultural University granted project allowance at the rate of 10% of the basic pay whenever new campuses are implemented.

Since this Agricultural college affiliated to Tamil Nadu Agricultural University is also a new college, the staff of this college requested the Govt.of Pondicherry to grant project allowance on par with the Agricultural colleges under Tamil Nadu Agricultural University. The request of the staff of PAJANCOA, Karaikal has considered by the Govt. of Pondicherry very sympathetically and permitted the staff of PAJANCOA, Karaikal to discuss the matter in person with the Development Commissioner on 10.6.90. Since then the matter was given due consideration and finally the Government decided that the subject may be considered by the Governing Body of the PAJANCOA(Karaikal) Society and its decision may be sent to the Govt.of Pondicherry for further orders.

The project allowance may be sanctioned for five years from the incaption of the college because the staff strength in the initial period was small and only those staff have faced the major difficulty in establishing the college. The additional expenditure owing to the grant of project allowance from 2.10.87 to 30.9.92 will be around Rs.7.7 lakhs (Rupees Seven lakhs and seventy thousand only). If the project allowance is granted from 1.6.90 to 31.5.95, the total monetary requirements work out to Rs.18 lakhs (Rupees Eighteen lakhs only). Considering the financial implications, it would be reasonable to grant project allowance to the staff of the college since its inception for a period of five years.

AGENDA ITEM NO.11 TO CONSIDER THE SCALE OF PAY FOR PHYSICAL DIRECTOR.

Creation of the post of physical Director was accepted in the seventh meeting of the Governing Body. A Physical Director has been appointed in the college on deputation from the Department of Education, Govt.of Pondicherry. In the college, no pay scale under UGC pattern has so far been fixed for the Physical Director. In the G.O.Ms.No.311/Ag(AU) Dept., dated 24.4.90 of Government of Tamil Nadu, the pay scales for Physical Directors have been revised on the basis of recommendations of the UGC. Accordingly the scale of pay of the Physical Director in the cadre of Assistant Professor is 2200-75-2800-100-4000. Since the UGC scales of pay has been accepted for the different cadres of teaching staff in PAJANCOA, Karaikal, the revised scale of pay prescribed for Physical Director may also be adopted in the college.

The Governing . Body is requested to consider the proposal and approve the revised scale of pay for the Physical Director in the cadre of Assistant Professor.

TO CONSIDER THE CREATION OF POSTS OF SUPPORTING STAFF FOR THE COLLEGE.

The Pandit Jawaharlal Nehru College of Agriculture, Karaikal is entering into the fourth year, from 2.10.90. The first batch of students admitted in 1987-88 are now in the fourth year B.Sc., (Ag).
